Section 1: That a three-year Agreement with up to two one-year renewals for comprehensive parking software and services solutions, on a fee-per-service basis in an amount not to exceed \$80,000.00 paid by the City of Key West, through the National Cooperative Purchasing Alliance Master Agreement for Parking Products and Services is hereby authorized, pursuant to Section 2-797(3) of the Code of Ordinances.
