24-5579 Awarding Request for Proposals #24-003, Strategic Planning Services

Introduction

Staff respectfully requests the City Commission accept and approve the ranking made by the Strategic Planning Services selection committee for Strategic Planning Services and authorize the City Manager to negotiate and execute a contract, subject to City Attorney review and approval, with the highest ranked proposer, Public Works, LLC.

Background

On July 9, 2020, the City Commission awarded RFP 005-20 Strategic Planning Services to Elisa Levy Consulting to develop a comprehensive, multiyear Strategic Plan for the City of Key West via Resolution 20-131. This selection resulted in the development of "Key West Forward – The Strategic Plan for the City of Key West 2021-2024," and subsequent adoption of the plan via Resolution 21-195 at the September 14, 2021, City Commission meeting.

The "Key West Forward" strategic plan focused on six priorities within the City of Key West which were identified via extensive surveys and workshops with the City Commission, City of Key West Employees, and citizens of the City of Key West. These priorities were identified as:

- 1. Affordable Housing
- 2. Sea Level Rise
- 3. Roads and Sidewalks
- 4. Environmental Protection
- 5. Cleanliness
- 6. Traffic & Pedestrian Friendliness

City Commission and City Staff put forth a lot of effort into the goals and plans identified in the "Key West Forward" plan. We are now in 2024, and the need for the continuation and update of the City's strategic planning process is needed.

On December 7, 2023, Request for Proposal (RFP) #24-003, Strategic Planning Services, was formally advertised. The RFP solicited proposals from qualified, professional consultants to coordinate, compile data, and help facilitate the City's comprehensive strategic planning efforts to update the Strategic Plan and identify opportunities for engagement in new initiatives consistent with the City of Key West's mission and identified community needs. The due date and time for the receipt of proposals was established for January 9, 2024 at 3:00 p.m.

Addenda 1 and 2 were released extending the due date and time for the receipt of proposals to January 25, 2024 at 3 p.m. and Addendum 3 provided answers to questions sent in by potential proposers.

The following is a list of proposals received:

- 1. Analytica
- 2. Public Works, LLC
- 3. Wise Business Plan, LLC

On February 22, 2024 at 2:00 PM., the Strategic Planning Services selection committee met, in a properly noticed meeting, to discuss and rank the proposals. The proposals were ranked with the following criteria and scoring:

Procurement

The Fiscal Year 2023-2024 City Manager budget has identified \$30,000 in Professional Services, account number 001-1201-512-3100 for the continuation of the City of Key West's strategic planning efforts. A budget transfer in the amount of \$19,950 from General Fund Reserves, account number 001-1900-519-9803 will be needed to fully fund the Strategic Planning engagement.

Recommendation

The City Manager's Office recommends the City Commission approve the Strategic Planning Services firm ranking as presented by the Strategic Planning Services selection committee and authorize the City Manager to negotiate and execute a contract, subject to City Attorney review and approval, with the highest ranked proposer, Public Works, LLC.
