A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF KEYSTAR, INC (KEYSTAR) RECEIVED IN RESPONSE TO INVITATION TO BID (ITB)#23-005 FOR FREDERICK DOUGLASS COMMUNITY CENTER (PROJECT BV55021701) IN THE TOTAL AMOUNT NOT TO EXCEED \$7,985,927.86; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the construction of the New Frederick Douglass Community Center (111 Olivia Street) was recommended as the Number 2 Priority Capital Project in the Bahama Village Community Redevelopment Subarea Visioning and Capital Projects Work Plan; and

WHEREAS, the City Commission, sitting as the Community Redevelopment Agency, approved the recommendation via Resolution 18-038; and

WHEREAS, four bids were received in response to ITB 23-005, with Keystar, Inc. submitting the lowest responsive bid; and

WHEREAS, City Staff finds lowest bid to be responsive and responsible, and recommends award of the bid to Keystar,

Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of Keystar, Inc. is hereby awarded in response to ITB 23-005 for the New Frederick Douglass Community Center, in the amount not to exceed \$7,985,927.86.

Section 2: That the project is funded in account 601-5502-555-6200, Project BV55021701. Any additional necessary budget adjustments or amendments are hereby authorized.

Section 3: That the City Manager is hereby authorized to execute a contract in substantial conformance with the bid documents upon consent of the City Attorney.


Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by signature of the Presiding Officer and the Clerk of the Commission.

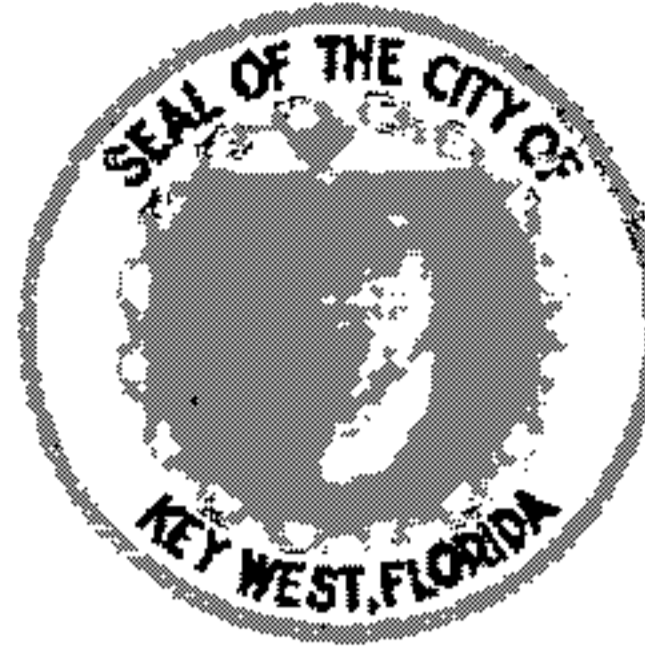

**Introduction**

Approve the construction bid award to Keystar, Inc. for the proposal received in response to Invitation to Bid (ITB) 23-005 for the Frederick Douglass Community Center. Authorize the City Manager to execute the contract upon successful negotiation including consideration of add alternates and deductive alternates and provide for any necessary budget transfers/amendments.

**Background**

The project was initiated in August of 2017 as part of Resolution 18-038. At its meeting on August 10, 2017, the Bahama Village Redevelopment Advisory Committee (BVRAC) by Resolution 18-038, recommended to the Community Redevelopment Agency (CRA) the approval of the Bahama Village Community Redevelopment Subarea Visioning and Capital Projects Work Plan, prepared by Zyscovich, Inc. The redesign and construction of an expansion to the Frederick Douglass Gymnasium was recommended as the number 2 priority capital project in the Visioning Plan. The City Commission, sitting as the CRA, approved the recommendation via Resolution 18-038.

The project timeline following the recommendation is as follows:

- Resolution 19-150: Commission approved the Architectural RFQ ranking and selection of K2M Design.
- Resolution 19-224: Commission approved K2M's contract and fee proposal.
- Resolution 19-328: Solar Panel report for major development of City Buildings.
- Resolution 20-028: K2M Amendment 1
- Resolution 20-160: K2M Amendment 2
- Planning Approvals: DRC- 09.17.2021, Planning 01.20.2022, HARC 01.25.2022, Tree 02.10.2022.
- Resolution 22-091 April 5, 2022, City Commission approval to proceed with Major Development Plan.

On May 30, 2023, the City received four bid proposals as outlined below:

Pedro Falcon Contractors, Inc.	\$8,014,478.00
Marino Construction Group, Inc.	\$8,953,591.22
D. L. Porter Constructors, Inc.	\$9,286,070.95

The bid schedule also included bid add alternates and deductive alternates for casework and storage, sound panels, backup generator, cistern and irrigation system, stair railings, terrazzo flooring, and solar power system. These alternates will be considered as part of the negotiations between the Contractor and City Manager.

### **Procurement**

The Frederick Douglass Community Center project currently has an available project budget in the amount of \$5,013,512. The contract amount of \$7,972,416 leaves a deficit in the amount of \$2,972,416. The deficit will be funded by utilizing the Bahama Village CRA reserves in the amount of \$1,080,270 and an American Rescue Plan Act funding allocation in the amount of \$1,392,782. The City of Key West was also recently awarded a grant in the amount of \$500,000 which will cover the remainder of the funding necessary to award this bid. Once all budget transfers and funding allocations have been appropriated, the contract amount of \$7,985,927.86 will be funded from Bahama Village CRA account number 601-5502-555-6200, project number BV55021701.

### **Recommendation**

The City Manager's Office recommends that the Mayor and City Commission approve the construction bid award to Keystar, Inc. for the proposal received in response to Invitation to Bid (ITB) 23-005 for the Frederick Douglass Community Center and authorize the City Manager to execute the contract upon successful negotiation including consideration of bid add alternates and deductive alternates and provide for any necessary budget transfers/amendments.
