A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING SLOPPY JOE’S ENTERPRISES, INC. TO CONDUCT AN EVENT FOR HEMINGWAY DAYS ON SATURDAY, JULY 22, 2017, FROM 12:00 NOON TO 11:00 P.M. PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF GREENE STREET BETWEEN DUVAL AND ANN STREETS FROM 11:00 A.M. TO 12:00 MIDNIGHT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Sloppy Joe’s Enterprises, Inc. wishes to conduct the annual Hemingway Days look-alike contest as a fundraiser for Hemingway Look-a-like Society; and

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida;

SECTION 1. That Sloppy Joe’s Bar is hereby granted permission to conduct Hemingway Days Annual Papa Look-A-Like Contest on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager, and 25% of gross revenue or \$1000,00, whichever is greater shall be donated to the Hemingway Look-a-like Society.

SECTION 2. That Sloppy Joe’s is hereby granted permission for the closure of Greene Street between Duval and Ann Streets on the date and during the hours stated above.

SECTION 3. That pursuant to Section 18-86 of the Key West Code of Ordinances, Sloppy Joe’s Enterprises, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 4. That Sloppy Joe's will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 5. This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
