A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A CONSTRUCTION PROJECT FOR ANGELA STREET ACCESS TO THE TRUMAN WATERFRONT PARK IN AN AMOUNT NOT TO EXCEED \$217,960.77 BY CHARLEY TOPPINO & SONS, INC., PURSUANT TO SECTION 2-797(4)(b) OF THE CODE OF ORDINANCES; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 15-326, the Naval Properties

Local Redevelopment Authority (LRA) awarded a bid for Truman

Waterfront Park Phase 1A project to Charley Toppino and Sons,

Inc.; and

WHEREAS, construction of Angela Street Access to the Truman Waterfront Park is part of the Truman Waterfront Master Plan, and design of the project was prepared by Stantec Consulting Services, Inc., pursuant to Resolution 15-247; and

WHEREAS, the Angela Street Access to Truman Waterfront
Park project is fully funded and must be completed in close
coordination with construction of an adjacent parking area,
drainage improvements and roadway access transitions that are
components of Phase IA of the Truman Waterfront Park project;
and

WHEREAS, the City Manager finds that it is in the best interests of the City to exempt this project from competitive bid requirements, pursuant to City Code section 2-797(4)(b);

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That an agreement between the City and Charley Toppino & Sons, Inc. for construction of the Angela Street Access to the Truman Waterfront Park is hereby authorized in the amount of \$217,960.77, pursuant to Section 2-797(4)(b) of the Code of Ordinances.

Section 2: That adequate funds are allocated in account No. 102-4102-541-6300/Project GN 1511.

Section 3: That the City Manager is authorized to execute any necessary documents related to the expenditures described herein, upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
