A RESOLUTION OF THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY (CRA) ACCEPTING THE WITHDRAWAL OF DOUGLAS N. HIGGINS, INC. (HIGGINS) FROM THE CONTRACT AWARDED IN RESOLUTION 16-355 FOR THOMPSON FISH HOUSE WALL RESTORATION; AWARDING THE BID OF BELLA CONSTRUCTION IN RESPONSE TO ITB 028-16 FOR THOMPSON FISH HOUSE WALL RESTORATION AT KEY WEST HISTORIC SEAPORT IN THE AMOUNT OF \$665,525.34; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 16-355 the CRA awarded the bid of Douglas N. Higgins, Inc. for Thompson Fish House Wall Restoration; and

WHEREAS, after in-water inspections prior to the commencement of construction, Higgins submitted a letter of withdrawal for the project on February 14, 2017, based upon their concern about significant unforeseen conditions; and

WHEREAS, the next-lowest bidder in response to ITB 028-16 is Bella Construction, Inc., and after discussion with staff, the project architect and engineer, Bella Construction verified that they would hold their original bid price of \$665,525.34 and accept the contract if awarded; and

WHEREAS, at its meeting of February 15, 2017, the Key West Bight Management District Board recommended withdrawal of the contract award to Higgins, and approving a contract award to Bella Construction Key West, Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR

AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1: That the bid awarded in Resolution 16-355 to Douglas N. Higgins, Inc., in response to ITB 028-16 is hereby cancelled at the request of the contractor.

Section 2: That the bid of Bella Construction Key West,
Inc. in the amount of \$655,525.34 in response to ITB #028-16 KWHS
- Thomson Fish House Wall Restoration, is hereby awarded.

Section 3: Funds are budgeted in the Key West Bight Building Fund - Account #405-7503-575-6200 (Project KB1301 - Thompson Fish House Structural Repairs).

Section 4: That the City Manager is authorized to enter into a contract in conformity with the bid documents upon the advice and consent of the City Attorney.

Section 5: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.
