Dear Mr. Steckly

First, I would like to thank you and the City of Key West for allowing Blue Goose the ability to provide a proposal for the Removal and Replacement of the Seawall for Truman Annex / NOAA Station. We worked diligently to prepare this work paper proposal and further would like to thank you for the consideration. At this time, it has come to our attention, via research of the agenda items for this week, the City of Key West, is intending to award this contract to Ebsary Foundation. I have attached the proposed agenda for reference in case this intent is not the anticipated path being taken with this project.

Currently, Blue Goose is pondering the intent to award to Ebsary Foundation based solely upon a bid package being presented that should have been deemed "Non-Responsive". As we are all familiar, as well as warned by both documents and pre-bid staff, previous to every bid, detailed attention should be paid to the bid requirements, specifically the "required" bid certifications and affidavits. Pursuant to discussion on this topic, I have attached the City prepared bid tabulation sheet for this specific proposal request. As is typical, all contractors that submitted proposals for this project, are listed, airing either their faultlessness or deficiencies with regard to bid package presentation. As is evident on the bid tabulation sheet, Ebsary Foundation failed to remit, not one, but all of the required affiant forms with their original bid proposal. These forms include the Overall Indemnification Form, Anti Kick Back Affidavit, Public Entity Crimes Affidavit, Non-Collusion Declaration, Florida Trench Safety Act Affidavit, Cone of Silence Affidavit and the Domestic Partnership

Affidavit. Again, all of the aforementioned required forms were missing from the bid proposal package.

According to the Request for Proposal instructions, each proposal had to arrive in sealed envelopes as a complete packaged defined by the bid instructions. This complete package included the required affidavits as previously described. Furthering our speculation to award, the attached bidder's proposal checklist provides two simple instructions. First, inclusive to package No. 1, the following instruction is provided:

"Bidders shall execute and include the following with Package No.1:

- Indemnification Form Attachment K
- Anti-Kickback Affidavit Attachment L.
- Public Entity Crimes Form Attachment M
- Non-Collusion Declaration and Compliance Attachment N
- Florida Trench Safety Act Compliance Attachment O
- Cone of Silence Affidavit Attachment P
- Equal Benefits for Domestic Partners Affidavit Attachment Q

Final instructions for this section come as the following statement:

"Failure to include the above forms may result in a determination that the proposal is non responsive."

Providing further example as definition for a non-responsive bid, please find attached the required affidavits mentioned above executed by Ebsary Foundation. Although producible at this point, it is quite clear Ebsary Foundation executed, as well as remitted, these forms after the bid deadline. Requests for Proposals were due on Thursday, March 2, 2017 at 3:00 pm. Although original submission by Ebsary appears timely, the March 24, 2017 execution date for the required affidavits is more than 3 weeks delinquent.

Currently, Blue Goose Construction is ranked #1 pertaining to price with a bid differential of \$1,975.00 lower than Ebsary Foundation's presentation on a comprehensive \$1.161 million construction package. Blue Goose is not privy to Ebsary Foundations technical approach, but by bid tabulation, Blue Goose finds ourselves a solid second. Overall rankings place Blue Goose second to Ebsary by the narrow margin of 11 points or a narrow 2% of rankings.

Based upon the lack for need of disqualification based upon price and the close ranking of each groups technical approach, Blue Goose feels at this time, a default to proper procedure and required requests should be the demarcation that provides settlement for this RFP bid process. With all required affidavit forms being omitted, executed and provided several weeks after bid presentation and the failure to provide these forms as a matter of rule, Blue Goose feels the RFP provided by Ebsary Foundation should be deemed Non-Responsive and should not be allowed for consideration.

Presently, we only became aware of the intention to award this project on Friday March 31, 2017. Blue Goose was never notified of an intention to award and garnered our education from the attached published agenda. The current agenda provides for a motion to award this project on behalf of Ebsary Foundation for the installation of the Truman Annex Improvements based upon what Blue Goose would determine to be final ranking. As mentioned previous, current ranking for this proposal should not even be considered as the bid fell short of required affidavits and should be deemed Non-Responsive.

Should the City of Key West move forward with the award to Ebsary Foundation, without providing fair and equal weight for mandated and required bid preparation requirements, Blue Goose will have no other recourse but to file a formal protest.

Please feel free to call and discuss this matter. Blue Goose considers this review extremely important and given that time is of the essence, we are requesting an expedited response.
