Dear Chief Lee:

I am bringing this matter to your attention, because I believe, when the evidence is looked at impartially, charges should be brought against Michael Winkner.

I realize that I do not come off as the most pristine victim, however, I do feel that Ofc. Rodriguez (ARod, as he affectionatley reffered to himself to an unidified male at the address of the incident), let his bias interfere with the proper outcome of the events.

Unfortunately, Ofc. Rodriguez' body cam did not record the first 4 minutes (approximately) of my interaction with him, but clearly he made some incorrect assumptions, which he then passed on to Sgt. Barrios - which also affected the outcome. AT NO TIME DID I EVER STATE EVER BEING IN A CRASH OR HAVING TO LAY DOWN MY SCOOTER AS WRITTEN IN RODRIGUEZ' NARRATIVE 1.

What is not seen on Ofc. Rodriguez' body cam is my explanation of what took place - so let me reiterate that here:

While driving my scooter, (Road and direction were inaccurately stated) Mr. Winkner was riding in the same lane - he was on my left. When we reached the intersection he executed a right turn, immediately in front of me - he cut me off. This caused me to swerve to avoid contact and an accident. AT NO TIME DID I INDICATE TO OFC. RODRIGUEZ, THAT THERE WAS A CRASH OR WRECK OF ANY SORT. (a better explanation can be seen in Sgt Barrios body cam of the event)

I was able to maintain control of my scooter - and proceeded to follow the direction Mr. Winkner travelled with the intention of recording his plate number to report for reckless driving. I stopped my scooter where Mr. Winkner was stopped at Catherine St., to begin recording his plate number, when Mr Winkner got off his scooter, he advanced on me, grabbed my scooters' handbrake and peeled it back (just as Ofc. Rodriguez identified in his report to Sgt. Barrios), he then proceeded to pummel be about my head and face knocking me off of my scooter. It was not until I was able to regain myself that I defended and struck Mr. Winkner in return.

At no time did Rodriguez inquire as to my injuries even though they were very visible and collaborated what I told Rodriguez.

I was able to essentially convey what happened to Sgt. Barrios, (and that was recorded on his body cam) but he had already been briefed by Ofc. Rodriguez, who called this a road rage incident. I had no road rage, I was taking information to report to the authorities. I think the fact that there was no damage to my scooter indicative of a wreck or crash, led them to believe that this was road rage. Of course there was no wreck damage to my scooter, I maintained control - but nobody asked me that.

Looking objectively at the evidence - that the damage incurred to my scooter and physically to my person is compatible with Mr. Winkner advancing on me, grabbing at my scooter, then battering me - I hope you will agree that charges should be brought against him.

When you review Ofc. Rodriguez' body cam, you will notice a distinct difference in tone used by him, between myself and Winkner. He was clearly biased in favor of the aggressor due to a mutual friend, and as such took what he was saying to be the truth... that I simply got mad because he passed me. (see body cam ARod)

I put this to you for consideration, even after reviewing the videos that DO NOT make look like a completely rational individual, due in a large part to a head trauma that I suffered at the hands of Michael Winkner (I went to the hospital the next day and received concussion treatment) Not once did Ofc. Rodriguez take into consideration all the physical damage that was clearly present, the bending of the brake handle, and a explanation by Winkner that does not support his claims.

Officer Rodriguez either knew or was a friend of a friend by his own admission in his body cam recording.

Officer Rodriguez took different and bias tones between the parties. (see body cam) Officer Rodriguez took great pleasure in taking my DL, having my scooter towed, seizing my license plate. (see body cam.)

Officer Rodriguez took these pleasures in the presence of the house hold inside their courtyard. (see body cam)

Officer Rodriguez reported either inaccurate or falsely. Missing the first 3/4 minutes of initial contact from body cam.

Officer Rodriguez report and narrative seems to bank on No Damage to my scooter, which was his perspective of the events and not what I reported. There is no place in any of the body cams or 911 call that I ever states I was involved in an accident where I crashed. I think this officers objectivity was skewed by his personal feelings and also knowing one or more of the residents at this location.

Officer Rodriguez refused to press any charges on my behalf against Winkner, but offered and encouraged Winkner to press charges against me...in my opinion, only because he had a bigger cut. (see body cam)

At the very least officer Rodriguez should be directed to correct the inaccuracy in his report, (clearly my DOB and age) along with what I reported appears nowhere in his narrative. Sgt. Barrios asserts that the DOB error is a typo, which I would agree with but Rodriguez had my DL witch with-in the number shows my birth year "60" he then enters the DOB as 12/10/1969 and my age as 46. At the time of the incident I was 55.

Last night, at approximately 9:00pm, I spoke with Lt. Tripp, after a short conversation, it was determined that it was not going anywhere. Instead of arguing with him, I ended the call by saying that I was going to sue the City of Key West. Before that takes place, I hope you look at all of the evidence and a different conclusion is made and charges are brought against Winkner. It is not my wish to file a civil suit against KWPD.

It seems that the higher I go the more resistance I get in an effort that appears to protect your officers. The more someone tries to quiet me, the louder I become. I am hoping for a full explanation, after a review of all of the evidence as to the decision that has been made thus far and why no charges will be made against Winkner.

Lt. Tripp told me to go to the State Attorneys office if I wish to file charges, because KWPD was not going to.

The State Attorneys office says that charges must be brought by the responding entity.

I do not wish to be put into a revolving door I am only looking for a quick conclusion so I can make informed decisions on how I should proceed.



I have reviewed your email to Chief Lee, as well as the reports, 911 call and Body Worn Camera video regarding your case. I am not sure if you are aware, but on December 20, 2016, Ofc. Rodriguez wrote a supplemental report changing the classification of the case to a Battery. I believe this was prompted by your conversation with Lt. Tripp. Ofc. Rodriguez will also be correcting your date of birth in an additional supplemental report on his next duty day. If you feel your side of the incident was not properly documented. I will be happy to meet with you and do a supplemental report documenting what you would like added to the case. I will be out of town until January 2, 2017, for the holidays but will be happy to meet with you upon my return.

At this time, based on the evidence I have heard, the information you provided in your email which was not on camera or in a report; as well as Ofc. Rodriguez's investigation there is not enough probable cause to arrest Mr. Wirkner. I realize that I do not come off as the most pristine victim, however, I do feel that Ofc. Rodriguez (ARod, as he affectionatley reffered to himself to an unidified male at the address of the incident), let his bias interfere with the proper outcome of the events.

Unfortunately, Ofc. Rodriguez' body cam did not record the first 4 minutes (approximately) of my interaction with him, but clearly he made some incorrect assumptions, which he then passed on to Sgt. Barrios - which also affected the outcome. AT NO TIME DID I EVER STATE EVER BEING IN A CRASH OR HAVING TO LAY DOWN MY SCOOTER AS WRITTEN IN RODRIGUEZ' NARRATIVE 1.

What is not seen on Ofc. Rodriguez' body cam is my explanation of what took place - so let me reiterate that here:

While driving my scooter, (Road and direction were inaccurately stated) Mr. Winkner was riding in the same lane - he was on my left. When we reached the intersection he executed a right turn, immediately in front of me - he cut me off. This caused me to swerve to avoid contact and an accident. (this was done from his anger because in his own words I was driving to "SLOW") AT NO TIME DID I INDICATE TO OFC. RODRIGUEZ, THAT THERE WAS A CRASH OR WRECK OF ANY SORT. (a better explanation can be seen in Sgt Barrios body cam of the event)

I was able to maintain control of my scooter - and proceeded to follow the direction Mr. Winkner travelled with the intention of recording his plate number to report for reckless driving. I stopped my scooter where Mr. Winkner was stopped at Catherine St., to begin recording his plate number, when Mr. Winkner got off of his scooter, he advanced on me, grabbed my scooters' handbrake and peeled it back (just as Ofc. Rodriguez identified in his report to Sgt. Barrios), he then proceeded to pummel be about my head and face - knocking me off of my scooter. It was not until I was able to regain myself that I defended and struck Mr. Winkner in return.

At no time did Rodriguez inquire as to my injuries even though they were very visible and collaborated what I told Rodriguez.

I was able to essentially convey what happened to Sgt. Barrios, (and that was recorded on his body cam) but he had already been briefed by Ofc. Rodriguez, who called this a road rage incident. I had no road rage, I was taking information to report to the authorities. I think the fact that there was no damage to my scooter indicative of a wreck or crash, led them to believe that this was road rage. Of course there was no wreck damage to my scooter, I maintained control - but nobody asked me that.

Looking objectively at the evidence - that the damage incurred to my scooter and physically to my person is compatible with Mr. Winkner advancing on me, grabbing at my scooter, then battering me - I hope you will agree that charges should be brought against him.

When you review Ofc. Rodriguez' body cam, you will notice a distinct difference in tone used by him, between myself and Winkner. He was clearly biased in favor of the aggressor due to a mutual friend, and as such took what he was saying to be the truth... that I simply got mad because he passed me. (see body cam ARod)

I put this to you for consideration, even after reviewing the videos that DO NOT make look like a completely rational individual, due in a large part to a head trauma that I suffered at the hands of Michael Winkner (I went to the hospital the next day and received concussion treatment) Not once did Ofc. Rodriguez take into consideration all the physical damage that was clearly present, the bending of the brake handle, and a explanation by Winkner that does not support his claims.

Officer Rodriguez either knew or was a friend of a friend by his own admission in his body cam recording.

Officer Rodriguez took different and bias tones between the parties. (see body cam)

Officer Rodriguez took great pleasure in taking my DL, having my scooter towed, seizing my license plate. (see body cam.)

Officer Rodriguez took these pleasures in the presence of the house hold inside their courtyard. (see body cam)

Officer Rodriguez reported either inaccurate or falsely. Missing the first 3/4 minutes of initial contact from body cam.

Officer Rodriguez report and narrative seems to bank on No Damage to my scooter, which was his perspective of the events and not what I reported. There is no place in any of the body cams or 911 call that I ever states I was involved in an accident where I crashed. I think this officers objectivity was skewed by his personal feelings and also knowing one or more of the residents at this location.

Officer Rodriguez refused to press any charges on my behalf against Winkner, but offered and encouraged Winkner to press charges against me...in my opinion, only because he had a bigger cut. (see body cam)

At the very least officer Rodriguez should be directed to correct the inaccuracy in his report, (clearly my DOB and age) along with what I reported appears nowhere in his narrative. Sgt. Barrios asserts that the DOB error is a typo, which I would agree with but Rodriguez had my DL witch with-in the number shows my birth year "60" he then enters the DOB as 12/10/1969 and my age as 46. At the time of the incident I was 55.

Monday night, at approximately 9:00pm, I spoke with Lt. Tripp, after a short conversation, it was determined that it was not going anywhere. Instead of arguing with him, I ended the call by saying that I was going to sue the City of Key West. Before that takes place, I hope you

look at all of the evidence and a different conclusion is made and charges are brought against Winkner. It is not my wish to file a civil suit against KWPD.

It seems that the higher I go the more resistance I get in an effort that appears to protect your officers. The more someone tries to quiet me, the louder I become. I am hoping for a full explanation, after a review of all of the evidence as to the decision that has been made thus far and why no charges will be made against Winkner.

Lt. Tripp told me to go to the State Attorneys office if I wish to file charges, because KWPD was not going to.

The State Attorneys office says that charges must be brought by the responding entity.

I do not wish to be put into a revolving door I am only looking for a quick conclusion so I can make informed decisions on how I should proceed.
