A RESOLUTION OF THE CITY COMMISSION OF THE FLORIDA, CITY WEST, RESCINDING OF KEY RESOLUTION NO a 17-011; AUTHORIZING (8) POLICE PURCHASE OF EIGHT 2017 FORD INTERCEPTOR AWD SUV UTILITY MARKED POLICE PATROL VEHICLES (\$33,657.75 EACH) FROM GARBER FORD FLEET SALES, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES, PURSUANT TO FLORIDA STATE PURCHASING CONTRACT 21500000-16-1, IN THE TOTAL AMOUNT OF \$269,262.00 FOR USE BY THE KEY WEST POLICE DEPARTMENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 17-011 the purchase of nine (9) police sedans from Don Reid Ford was approved, but after further consideration, KWPD staff determined that AWD SUVs would provide more reliable, functional service; and

WHEREAS, KWPD staff has requested that the City Commission rescind the purchase of police sedans authorized in Resolution 17-011, and instead authorize the purchase of police SUV vehicles described in this Resolution; and

WHEREAS, this purchase is pursuant to section 2-797(3) of the Code of Ordinances;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That Resolution No. 17-011 is hereby rescinded, provided that no purchase has actually been made under said Resolution.

Section 2: That the purchase of a total of eight (8) 2017 Ford Police Interceptor AWD SUV Utility Marked Police Patrol Vehicles from Garber Ford Fleet Sales (\$33,657.75 each, pursuant to Florida State Purchasing Contract 21500000-16-1, pursuant to section 2-797(3) of the Code of Ordinances is hereby authorized in the total amount not to exceed \$269,262.00:

Section 3: That the purchase of these vehicles is budgeted in the FY 16/17 budget account #101-2101-521-6400.

Section 4: That this Resolution shall go into effect immediately upon its passage, adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
