A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH WELLS FARGO BANK, NA, PROPERTY OWNER(S) OF 3714 FLAGLER AVENUE, PERMITTING A RELEASE OF LIEN UPON PAYMENT BY THE OWNERS OF THE AMOUNT OF \$10,550.00; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, a property lien in the total amount of \$52,750.00, resulting from fines accrued in Code Compliance File No. 16-146, was promulgated upon owner of record, Wells Fargo Bank, NA

WHEREAS, on January 27, 2017, compliance was achieved and daily fines were discontinued, and on March 27, 2017, Code Compliance received a Request for and Release of Lien; and

WHEREAS, the City Manager negotiated with the property owner, and recommends to the City Commission the acceptance of a mitigated amount of \$10,550.00, which represents 20% of the original fine amount; and

WHEREAS, on May 16, 2017, the City Commission considered the owner's request to release the lien imposed on the property.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Manager, upon the advice and consent of the City Attorney, is authorized to enter into an agreement with Wells Fargo Bank, NY, the owner(s) of the property known as 3714 Flagler Avenue, to allow the City's release of lien upon payment of an amount of \$10,550.00

Section 2: That the property owner shall pay the reduced lien amount of \$10,550.00 within thirty (30) days of the date of this Resolution as a condition precedent to the release of the \$52,750.00 lien.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
