## NOTICE OF ADMINISTRATIVE HEARING BEFORE THE TREE COMMISSION OF THE CITY OF KEY WEST

June 1, 2017

An administrative hearing before the Tree Commission for the City of Key West will be held on **Tuesday, June 13, 2017,** at 5:00 p.m., at **Josephine Parker City Hall at Historic Glynn R. Archer School, 1300 White Street, Key West, Florida.** 

This hearing will be conducted pursuant to sections 110-288 et. seq. of the Key West City Code. The purpose of this hearing will be to determine if a code violation has been committed by the above named Respondents. Your presence is required at this Tree Commission meeting.

#### Date of alleged violation: prior to May 26, 2017 at 1 Duval Street

Alleged code violation: Sec. 110-321. Required.

- (a) Unless a tree removal permit approved by the tree commission and issued by the Urban Forestry Manager has been obtained, no person, whether on publicly or privately owned land, shall cause tree abuse or other harm, or major maintenance to, hatracking, transplanting, topping or removal of the following:
  - (1) Any tree listed as "specially protected" in section 110-253;





### Factual allegation: A protected Mahogany tree was removed without benefit of a tree removal permit.

If the Tree Commission for the City of Key West finds that there has been a violation of the above code section, it will elect to enter into a compliance settlement agreement pursuant to section 110-291 of the Key West City Code to include processing of an after-the-fact permit or recommend a fine and/or further hearing before the Special Master of the City of Key West pursuant to section 110-294 of the Key West City Code.

Attendees are hereby notified that a complete and accurate record of the proceeding is required under Florida Statute 286.0105 if an appeal is sought. Appellants are responsible for providing transcription services.


FROM: Karen DeMaria, City of Key West Urban Forestry Manager

An application was received requesting the removal of **(2) Mahogany trees**. An inspection of the property on May 26, 2017 documented that one of the mahogany trees had recently been removed. Discussions with the general manager, Joe Dantoni, determined that there was a miscommunication and the tree was accidently cut down earlier that day by The Tree Man. I contacted Sean Creedon-The Tree Man, and he said that there was a miscommunication.

Stump diameter measurement: 12.1" dbh

Recommendation: Recommend processing of an after-the-fact tree removal permit with full replacement requirements, 12.1 caliper inches of approved dicot or fruit trees, FL#1 to be panted on site.

A fine should be imposed against the contractor-first offense.


