A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING AND APPROVING THE RESTORATION AND RE-INSTALLATION OF THE 12-FOOT CIGAR SCULPTURE ON PERMANENT DISPLAY IN THE GATO VILLAGE POCKET PARK; ACCEPTING AND ACKNOWLEDGING A CONTRIBUTION FROM THE FUENTE FAMILY FOUNDATION TO PARTIALLY FUND THE SCULPTURE RESTORATION; AUTHORIZING AN EXPENDITURE OF UP TO \$3,000 FROM COMMUNITY FUND 110, PURSUANT TO SECTION 2-487(e) OF THE CITY CHARTER; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, at its regular meeting of June 12, 2017, and in Resolution 01-2017, the Art in Public Places Board (AIPP) unanimously recommended restoration of the 12-foot cigar sculpture at the Gato Village Pocket Park using a contribution from the Fuente Family Foundation in combination with funds provided from the Art In Public Places Advisory Board Fund (Community Fund 110); and

WHEREAS, the AIPP recommends acceptance of the proposal by the original artist, Reen Stanhouse, to perform the restoration.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: In accordance with the recommendation of AIPP, the City Commission approves and authorizes the restoration of the 12-foot cigar sculpture located at the Gato Village Pocket Park.

Section 2: That the Proposal for Restoration of the Gato Park Cigar by Island Iron & Ink/Reen Stanhouse is hereby approved.

Section 3: That the City Commission gratefully accepts and acknowledges the contribution of \$2,700.00 from the Fuente Family Foundation, as partial funding for this project.

Section 4: That the use of funds in an amount not to exceed \$3,000.00 from Community Fund 110, Art in Public Places, is hereby authorized for this project.

Section 5: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
