A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING A PROCUREMENT PURSUANT TO SECTION 2-797(2) AND SECTION 2-797(4)(b) OF THE CITY'S CODE OF ORDINANCES, FOR REPAIR AND SOD REPLACEMENT OF PORTIONS OF THE POINCIANA SOCCER FIELD BY T. MAC WILDER AND ASSOCIATES, IN AN AMOUNT NOT TO EXCEED \$43,260.06; AUTHORIZING THE USE OF BP FUNDING; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Poinciana Soccer field is used year-round for school programs, youth activities and youth athletic league games and practices. Many areas of the field are bare or damaged, which could cause for unsafe playing conditions; and

WHEREAS, recently a sidewalk was removed to create more playing area for the leagues; and

WHEREAS, the school year opens for students on August 16th, 2017, and the soccer and lacrosse seasons also commence in August, creating a limited time frame in which to complete repairs and improvements to the fields; and

WHEREAS, City staff requested price quotes from several vendors, but only one was able to provide both materials and labor to complete the necessary work within the completion window; and

WHEREAS, the City Manager acted without delay, using powers authorized under Section 2-797(2) of the City's Code of Ordinances, to authorize an emergency procurement in the amount of \$43,260.06

to ensure that the field can be promptly repaired and improved;

WHEREAS, pursuant to City Code Section 2-797(4)(b), the City Manager finds that exceptional circumstances exist to exempt a purchase from the competitive bid requirements in the best interests of the City; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the City Commission, in accordance with Section 2-797(2) and 2-797(4)(b) of the Code of Ordinances, hereby ratifies a contract for repairs and sod replacement of the Poinciana Soccer Field in an amount not to exceed \$43,260.06 from T. Mac Wilder and Associates.

Section 2; That funds received from BP Oil settlement.

General Fund Account 001-7201-572-4600, will used for this project.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
