A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING “KEY WEST HALF MARATHON LLC” TO CONDUCT THEIR 20th ANNUAL KEY WEST HALF MARATHON AND 5K RUN ON SATURDAY, JANUARY 13, 2018 FROM 8:00 A.M. TO 8:00 P.M. AND SUNDAY, JANUARY 14, 2018 FROM 5:00 A.M. TO 12:00 NOON AT THE WATERFRONT BREWERY, 200 WILLIAM STREET AND THE HALF SHELL RAW BAR, 231 MARGARET STREET; AUTHORIZING CERTAIN STREET CLOSURES THEREOF DURING THE EVENT; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The Key West Half Marathon LLC is hereby given permission to conduct their 20th Annual Key West Marathon and 5K Run on Saturday, January 13th and Sunday, January 14th 2018;

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida;

SECTION 1. That permission is hereby granted to conduct the Key West Half Marathon and 5K on the date and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

SECTION 2. That the Key West Half Marathon LLC. is hereby granted permission for the closure of certain streets throughout the city for the Half Marathon & 5K on the date and during the hours stated above.

SECTION 3. That the Key West Half Marathon LLC will be coordinating with the agencies outside of the City of Key West jurisdiction for their part in the race.

SECTION 4. That the Event organizers will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 5. The event organizer shall use spray chalk or another readily removable substance for all course markings placed on public property.

SECTION 6. This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
