RE: Request for business tax receipts for the retail sale of medical marijuana

Dear Mr. Smith

As you are aware, the City has not issued business tax receipts for medical marijuana sales for Dispensary Management, LLC at five locations in the city of Key West requested on January 3, 2017. The Constitutional Amendment regarding production, possession and use of medical marijuana charged the Department of Health with regulating medical marijuana in the State. Florida Statutes 381.986 and 385.212, as well as Florida Administrate Code Chapter 64-4 provide some regulatory framework for licensure.

In reviewing the applications submitted, we could not find any evidence that the Department of Health has authorized, registered, certified or licenses Dispensary Management, LLC to dispense medical marijuana.

Florida Statute 205.194 entitled "Prohibition of local business tax receipt without exhibition of state license or registration" reads in pertinent part:

(1) Any person applying for or renewing a local business tax receipt to practice any profession or engage in or manage any business or occupation regulated by the Department of Business and Professional Regulation, the Florida Supreme Court, or any other state regulatory agency, including any board or commission thereof, must exhibit an active state certificate, registration, or license, or proof of copy of the same, before such local receipt may be issued. Online renewals may provide for electronic certification by an applicant to meet this requirement.

As such I do not believe the City can issue the business tax receipts. The language of the statute clearly specifies that before a local receipt is issued, the applicant must provide proof of an active state certificate, registration, or license. Given that Dispensary Management, LLC has not provided such proof, the City will not be issuing the business tax receipts. Enclosed you will find your checks that were submitted with the applications.
