A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE EXPENDITURE OF AN ADDITIONAL \$30,000.00 PURSUANT TO THE AGREEMENT BETWEEN THE CITY AND M.T. CAUSLEY, INC. FOR FLORIDA DBPR LICENSED PROFESSIONAL SUBSTITUTE STAFFING ON A SOLE SOURCE BASIS PURSUANT TO SECTION 2-797(1) OF THE CODE OF ORDINANCES; AUTHORIZING NECESSARY BUDGET TRANSFERS AND AMENDMENTS TO INCREASE FUNDING BY \$30,000.00; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 17-109, the City Commission approved a contract agreement between the City and M.T. Causley, Inc., along with funding for professional substitute staffing in an additional amount of up to \$25,000.00; and

WHEREAS, due to several personnel vacancies, and on-going needs for plan reviews and inspections, the Building Official recommends approval of an additional expenditure in excess of \$20,000.00 for private inspection services for FY 16-17; and

WHEREAS, only Florida DBPR licensed professionals may perform construction inspections, plan reviews or function as a Building Official, and the City has found over a period of many years that M.T. Causley, LLC is the only company willing to provide substitute staffing for the City Building Department; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That additional funding, in the amount of \$30,000.00 for independent licensed inspectors and plan examiners, pursuant to the Agreement between the City and M.T. Causley, pursuant to Section 2-797(1) (b) of the Code of Ordinances is hereby approved.

Section 2: That a budget amendment in an amount of \$30,000.00 is authorized reflecting an increase in the Building Permit revenue account 001-0000-322-0000, and an accompanying increase to the Building Department Professional Services expenditure account, 001-2401-524.31

Section 3: That the City Manager is authorized to execute necessary documents upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
