FIRST AMENDMENT TO LEASE AGREEMENT

This First Amendment to Lease Agreement is entered into this 675 day of _______, 2012, by and between the City of Key West, Florida, a municipal corporation, (hereinafter "LESSOR") and the Key West Women's Club, Inc., a not-for-profit corporation organized under the laws of the State of Florida and a 501 (c)(3) exempt organization, (hereinafter "LESSEE").

Section 1: That Section 1. Term of the lease shall be renewed for a period of five (5) years, and shall apply to the Fantasy Fest activities for the years 2012 through 2016.

Section 2: Except as modified herein, the Lease Agreement as amended shall remain in full force and effect.
