
An application was received requesting the removal of **(1) Rubber tree**. A site inspection was done on July 19, 2017 and documented the following:

Tree Species: Rubber tree (Ficus elastica)

























Diameter: 49.6" - 24" = 25.6" regulated

Location: 20% (tree trying to merge with building, hot water heater, and

plumbing)

Species: 0% (on not protected tree list-regulated due to size)

Condition: 50% (fair to poor, large canopy, sprawling tree, typical rubber

tree/ficus growth pattern)
Total Average Value = 23%

Value x Diameter = 5.8 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Rubber tree at 830 Olivia Street to be replaced with 5.8 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.


