


An application was received requesting the removal of **(1) Gumbo Limbo tree**. A site inspection was done on October 4, 2017 and documented the following:



Tree Species: Gumbo Limbo (Bursera simaruba)







NOTE: Application submitted prior to Hurricane Irma impacts.

Diameter: 15.2" Location: 80% (Parking lot planter area.) Species: 100% (on protected tree list) Condition: 30% (very poor, there does appear to be a health issue with the tree-old dead branches seen in canopy, bark pitted and discolored-disease or insects?) Total Average Value = 70% Value x Diameter = 10.6 replacement caliper inches


Recommendation: Recommend approval of the removal of one (1) Gumbo Limbo tree at 3131 Northside Drive to be replaced with 10.6 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.
