





An application was received requesting the removal of **(1)** Star Apple and **(1)** African Tulip tree. A site inspection was done on October 24, 2017 and documented the following:

Tree Species: Star Apple (Chrysophyllum cainito)











Diameter: 13.6" Location: 80% Species: 50% (not on protected or not protected tree list) Condition: 50% (hurricane damage in canopy and old dead branches, according to property owner trunk lean more pronounced) Total Average Value = 60% Value x Diameter = 8.1 replacement caliper inches


No recommendation regarding removal. Root system seems to be intact. Canopy could use a major trim.


Tree Species: African Tulip (Spathodea campanulate)













Diameter: 43.3" Location: 60% (utility lines close to canopy) Species: 50% (not on protected or not protected tree list) Condition: 30% (very poor, structure poor-multitrunked, canopy a mess, tree species brittle) Total Average Value = 46% Value x Diameter = 19.9 replacement caliper inches

Every significant storm this tree drops large branches on property and neighboring walkway.

Recommend approval of the removal of one (1) African Tulip.




