A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PROCUREMENT APPROVED BY THE CITY MANAGER IN EXCESS OF \$20,000 AS ALLOWED UNDER SECTION 2-797(2) OF CITY'S CODE OF ORDINANCES, FOR THE PROCUREMENT FROM H D SUPPLY WATERWORKS, LTD OF DRAINAGE SYSTEM PIPE, FITTINGS AND INLET BASINS IN AN AMOUNT NOT TO EXCEED \$30,666.96; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, embankment erosion within the Donald Canal has created an immediately hazardous situation which endangers the safety of mobile home occupants at the Poinciana Trailer Park and backyard properties along Solana Village; and

WHEREAS, City staff obtained three quotes for drainage system materials, with H D Supply Waterworks, LTD submitting the lowest quote; and

WHEREAS, immediate action is necessary to prevent further embankment collapse, so the City Manager acted without delay, using emergency powers authorized under Section 2-797.(2) of the City's Code of Ordinances, to authorize an emergency procurement in the amount of \$30,666.96 to ensure that necessary supplies are available as quickly as possible; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: The City Commission, in accordance with Section 2-797(2) of the City of Key West Code of Ordinances, hereby ratifies an emergency procurement in the total amount of \$30,666.96 to H D Supply Waterworks, LTD for drainage systems pipe, fittings and inlet basins to quickly address the collapsing embankment hazard within the Donald Canal.

Section 2: That adequate funds are budgeted for Donald Canal Erosion Repair project supplies in account 402-3802-538-4600.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
