A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PROCUREMENT APPROVED BY THE CITY MANAGER IN EXCESS OF \$20,000 AS ALLOWED UNDER SECTION 2-797(2) OF CITY'S CODE OF ORDINANCES, FOR THE PROCUREMENT FROM PSI TECHNOLOGIES OF REPAIR AND REBUILD OF A 60 HP SUBMERSIBLE PUMP FOR LIFT STATION B IN AN AMOUNT NOT TO EXCEED \$26,762.00; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, during Hurricane Irma one of the two pumps at Lift Station B failed, and prompt repair of the pump is essential at one of the City's most critical lift stations; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to authorize an emergency procurement in the amount of \$26,762.00 to ensure that necessary repairs are made expeditiously; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: The City Commission, in accordance with Section 2-797(2) of the City of Key West Code of Ordinances, hereby ratifies an emergency procurement in the total amount of \$26,762.00 to PSI Technologies for repair and rebuild a 60 HP submersible pump for lift Station B.

Section 2: That the lift station B pump repair will be charged to account 001-1910-519-4600, Project number HU1701F01.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
