**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF
KEY WEST, FLORIDA, DIRECTING THE CITY MANAGER TO
OBTAIN A COST ESTIMATE FOR THE CONSTRUCTION OF ONE
ARTIFICIAL TURF SPORTS FIELD AT LITTLE HAMACA PARK
AND HAWK MISSILE SITE; PROVIDING FOR AN EFFECTIVE
DATE**

WHEREAS, a report of the City of Key West Engineering Staff regarding the possible placement of Multi-sports fields at the Hawk Missile Site concluded with an overall cost estimate of \$4.9 million dollars, due primarily to the expense of providing utilities to the fields; and

WHEREAS, there remains a very real need in the City of Key West for sports fields where our youth may exercise, playing soccer, lacrosse, football and other sports; and

WHEREAS, to have a viable plan for providing for additional recreational facilities, there is a need to downsize what can be realistically accomplished by the City due to fiscal limitations; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the City Manager is directed to prepare a cost estimate for the creation of one single sports field to be located at what maps presently show as "Sod Field A" at the Hawk Missile Site, Government Road, Little Hamaca Park, under the following conditions:

(a) The playing surface shall be as large as possible, maintaining the present berms, and the resultant field may not necessarily be of regulation size for soccer, football or lacrosse.

(b) The field shall be artificial turf.

(c) There shall be no potable water supply at the site.

(d) There shall be portable toilet(s)

(e) The field shall have lighting sufficient to illuminate the playing surface.

Section 2: That the City Manager shall present a cost estimate to the City Commission at the December 5, 2017 meeting.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
