ACTION STATEMENT:

This resolution will approve the attached Public Transportation Supplemental Joint Participation Agreement (SJPA) Number One with the Florida Department of Transportation (FDOT) to add additional funds of \$256,365.00 to the Truman Annex Seawall project. The City Manager will be authorized to execute the attached SJPA.

BACKGROUND:

The seawall abutting the National Oceanic and Atmospheric Administration (NOAA) facility and the Truman Annex boat ramp is currently in a state of significant disrepair as evidenced by undermining of the toe wall and settlement of wall backfill. The seawall is co-located on both City and NOAA property. NOAA is contributing to repair costs with a National Marine Sanctuary Foundation grant, as are Naval Air Station Key West (NASKW) via in-kind funds. The City has also been awarded a Florida Defense Support Task Force (FDSTF) grant.

In FY 2017, the City Commission accepted \$256,365.00 in FDOT grant funding through Joint Participation Agreement G0L18 / 441263-1 (Resolution 17-107) at a 50% State/50% City cost share to refurbish the Truman Annex seawall.

PURPOSE AND JUSTIFICATION:

In FY 2018, FDOT is providing additional funds of \$256,365.00 for a total of

\$512,730.00 to repair the seawall.

FINANCIAL IMPACT:

With the approval of the SJPA, the City will receive additional funds of up to \$256,365.00, Revenue Account 1010000 3349000 / TR1503. Project costs have been budgeted in Account 1014303 5436300 / TR1503.
