AN ORDINANCE OF THE CITY OF KEY WEST, FLORIDA, AMENDING CHAPTER 70, "TRAFFIC AND VEHICLES", ARTICLE III OF THE CODE OF ORDINANCES ENTITLED "SPEED LIMITS" BY ADDING SECTION 70-61 TO PROVIDE FOR MAXIMUM SPEED LIMITS IN CERTAIN SECTIONS OF THE CITY; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF INCONSISTENT PROVISIONS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Florida Statute 316.008 grants jurisdiction regarding speed limits over certain streets to local municipalities; and

WHEREAS, the City of Key West has numerous small and congested streets;

WHEREAS, the reduction of the maximum speed limit over certain local streets to twenty (20) miles per hour would serve to promote the health, safety and welfare of the citizens of Key West;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF KEY WEST, FLORÎDA:

Section 1: That Section 70-61 of Chapter 70 of the Code of Ordinances is hereby added as follows*:

Sec. 70-61 Maximum Speed Limits in Old Town Key West

The lawful speed limit on a City road, street or other vehicular use area to the south and west of White Street in any residential district shall be a maximum of twenty (20) miles per hour, except as otherwise provided by law. The City Commission may by resolution designate specific areas where the above-described maximum speed limit shall not apply.

Section 2: If any section, provision, clause, phrase, or application of this Ordinance is held invalid or unconstitutional for any reason by any court of competent jurisdiction, the remaining provisions of this Ordinance shall be deemed severable therefrom and shall be construed as reasonable and necessary to achieve the lawful purposes of this Ordinance.
