An application was received requesting the removal of **(1) Spanish Lime tree**. A site inspection was done on January 26, 2018 and documented the following:

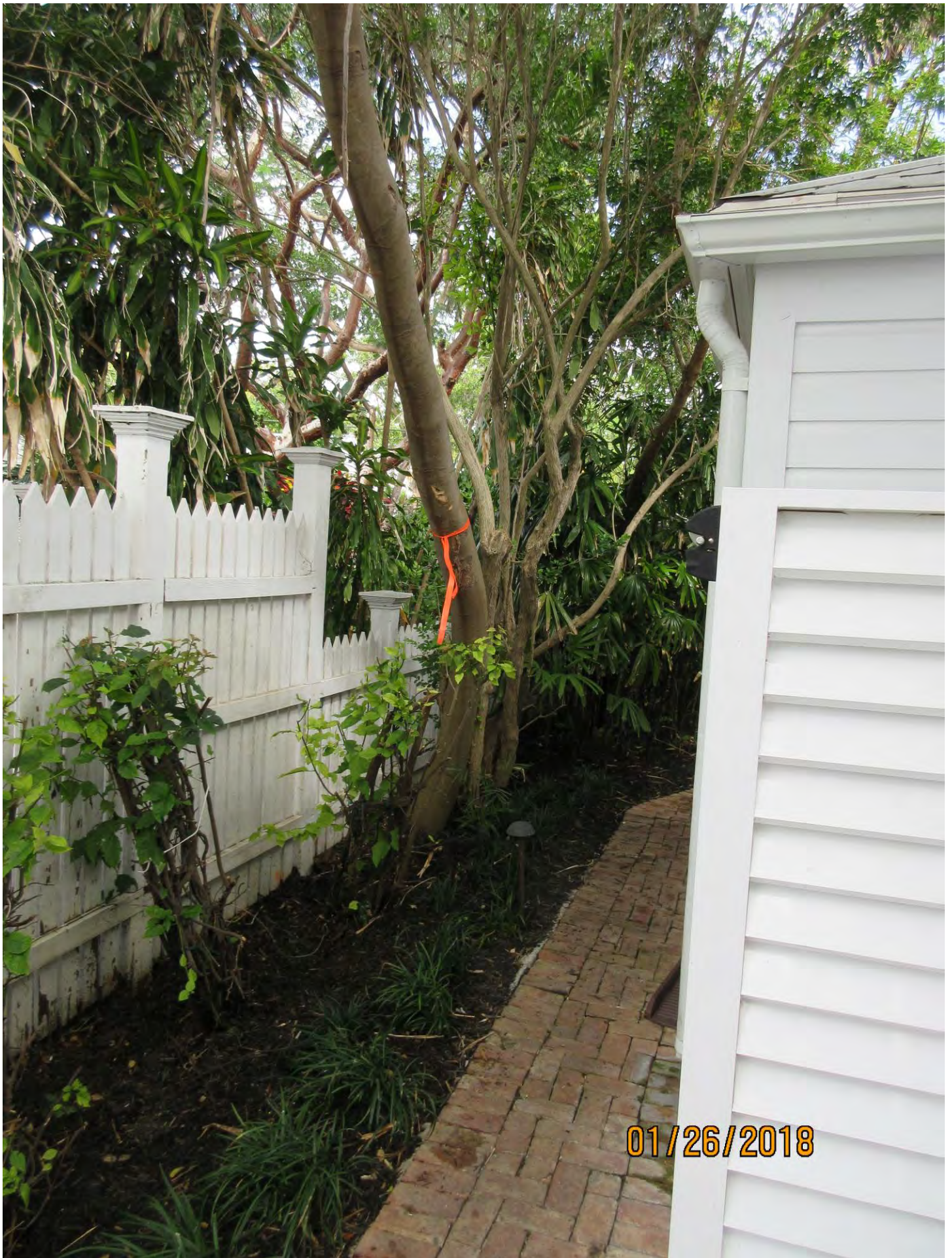
Tree Species: Spanish Lime (*Melicoccus bijugatus*)

Diameter: 8.2"

Location: 60% (close to fence and structures-small growth area)

Species: 100% (on protected tree list)

Condition: 50% (fair to poor, young tree with heavy growth lean toward neighboring property, hurricane damage-tree leaning more than prior to storm, root system appears to be weakened)

Total Average Value = 70%

**Value x Diameter = 5.7 replacement caliper inches**

**Recommendation: Recommend approval of the removal of one (1) Spanish Lime tree at 326 Whitehead Street to be replaced with 5.7 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.**
