RE: **3841 N. Roosevelt Blvd (permit application # T18-8834)**

An application was received requesting the removal of **(1) Green Buttonwood tree**. A site inspection was done on January 23, 2018 and documented the following:

Tree Species: Green Buttonwood (*Conocarpus erectus*)







01/23/2018

Diameter: 24.5" total (2 trunks)

Location: 20% (growing too close to fire suppression system)

Species: 100% (on protected tree list)

Condition: 50% (fair, long, sprawling tree with growth lean)

Total Average Value = 56%

Value x Diameter = 13.7 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Green Buttonwood tree at 3841 N. Roosevelt Blvd to be replaced with 13.7 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.

I did look at the two silver buttonwood trees located in the rear of the parking garage area around the fire system (see attached photos and notes).

Tree #1: Qualifies for emergency removal

Tree #2: Does NOT qualify for an emergency removal. It's removal will have to go in front of the Tree Commission. I do recommend processing a heavy maintenance trimming permit to remove the large trunk closest to the wheel. A heavy maintenance trimming permit is a staff approval process and a permit can be issued in a few days.

I have attached a copy of an application, letter of rep form and the approved tree list for you to give to the manager/owner of the property. The manager can sign on behalf of the property owner as long as the application includes a copy of the letterhead or business card with his name and title in it.

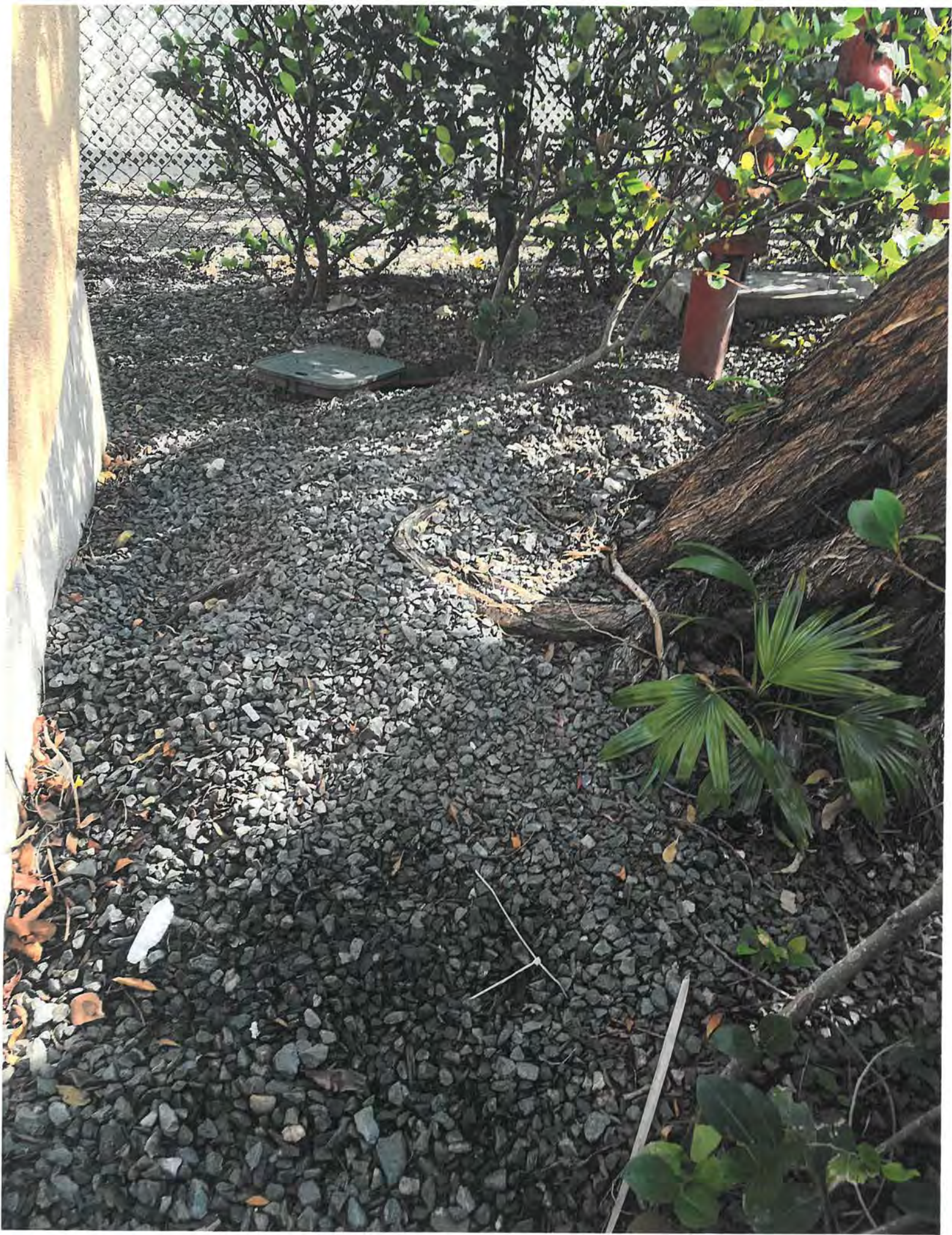

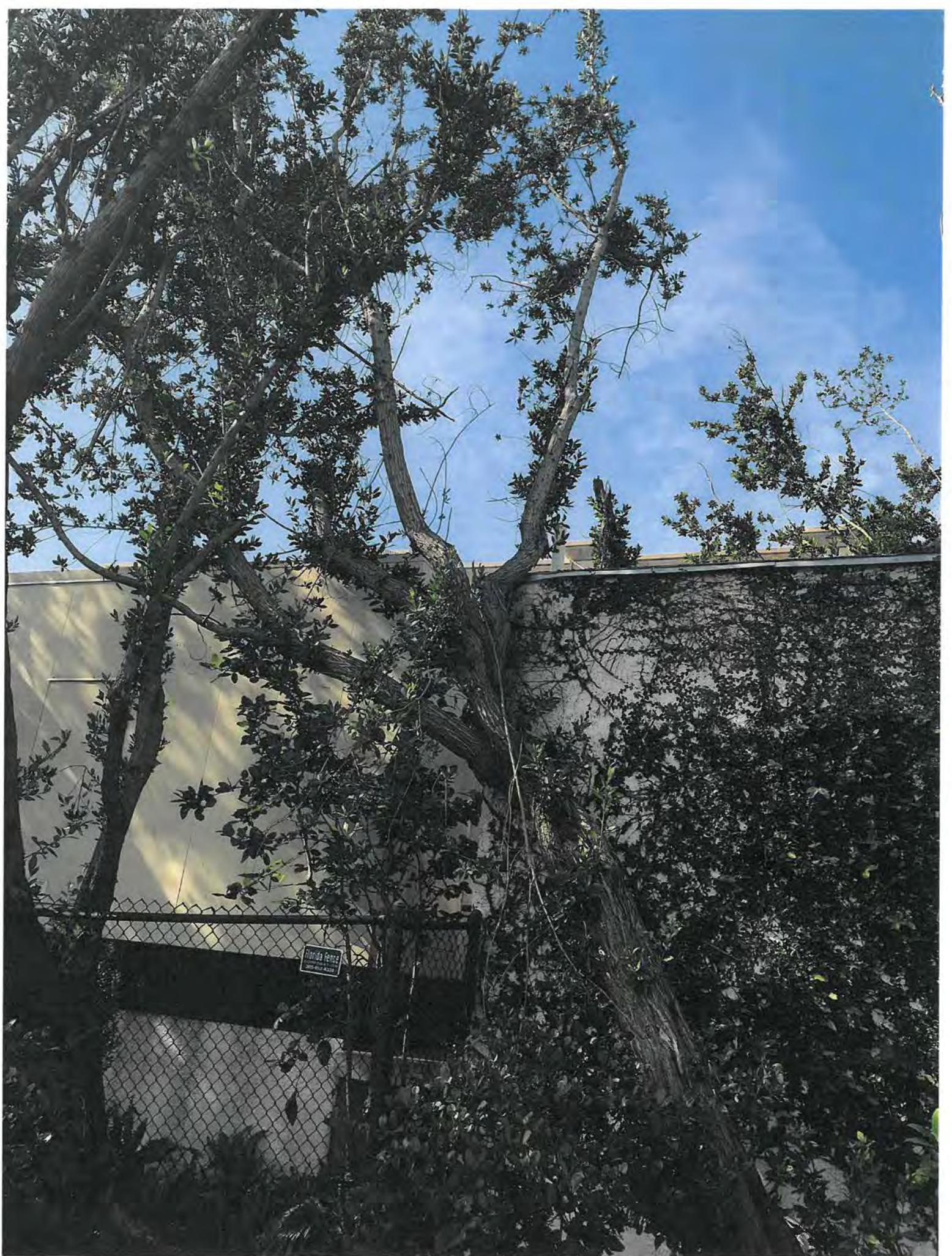

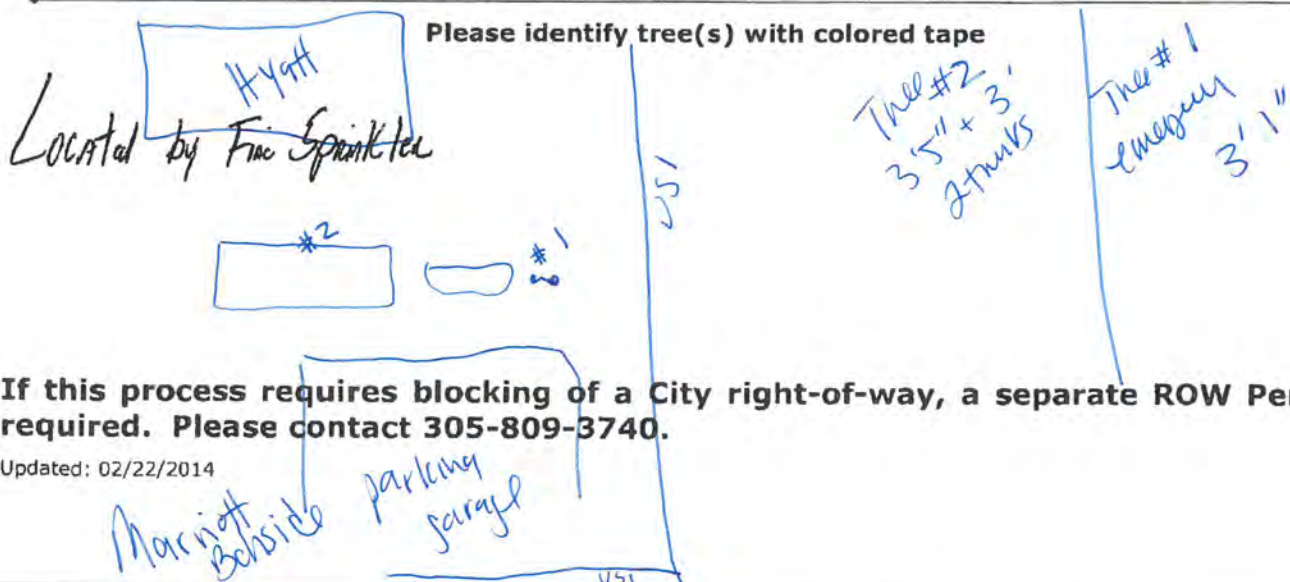
