AN ORDINANCE OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING ASSIGNMENT OF ALL STOCK OF DUCK TOURS SEAFARI, INC. FROM MICHAEL THOMAS, JR. TO BUGGY BUS, INC., PURSUANT TO SECTION 6. OF THE FRANCHISE GRANTED IN KEY WEST ORDINANCE NO. 11-02; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF INCONSISTENT PROVISIONS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Key West City Charter section 7.01(4) requires that the grant of a franchise must be done by ordinance; and

WHEREAS, in Ordinance No. 11-02, the Key West City Commission granted Duck Tours Seafari, Inc. a franchise agreement for amphibious sightseeing operations upon certain terms and conditions; and

WHEREAS, in Ordinance No. 11-21, the Key West City Commission authorized assignment of all stock in Duck Tours Seafari to Michael Thomas, Jr; and

WHEREAS, Michael J. Thomas, Jr. for Duck Tours Seafari, Inc. requested City Commission approval pursuant to section 6 of the Franchise Agreement contained in Ordinance 11-02, to transfer all stock of Duck Tours Seafari, Inc. to Buggy Bus, Inc.; and

WHEREAS, Buggy Bus, Inc. is currently the owner of a franchise within the City of Key West, and has previously provided financial information to the satisfaction of the City Manager; and

WHEREAS, the Key West City Commission finds that granting approval of this transfer of stock and resulting assignment of the franchise is reasonable within the intent of Ordinance No. 11-02 and will not adversely affect the safety or welfare of the residents and visitors of Key West.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF KEY WEST, FLORIDA:

Section 1: That, pursuant to section 6 of Key West Ordinance No. 11-02, a transfer of all stock of Duck Tours Seafari, Inc., from Michael J. Thomas, Jr. to Buggy Bus, Inc. is hereby approved.

Section 2: That all remaining provisions of the Franchise granted in Ordinance No. 11-02 remain in full force and effect.

Section 3: If any section, provision, clause, phrase, or application of this Ordinance is held invalid or unconstitutional for any reason by any court of competent jurisdiction, the remaining provisions of this Ordinance shall be deemed severable therefrom and shall be construed as reasonable and necessary to achieve the lawful purposes of this Ordinance.
