MOTIONS AS MOOT**


THIS CAUSE came before the Court upon the parties' Joint Notice of Settlement [ECF No. 110]. The parties seek the requested relief to prepare and finalize a settlement agreement, which is subject to approval by the City of Key West City Commission. After careful consideration, it is hereby:

**ORDERED AND ADJUDGED** as follows:

1. The parties shall file either a Notice of Dismissal (if the Defendant has not served an answer or motion for summary judgment) or a Stipulation of Dismissal (signed by all parties who have appeared in this action), **which must be filed with the Clerk of the Court**; a proposed Order of Dismissal or Final Judgment; and any other documents necessary to conclude this action **on or before March 26, 2018**.
2. If the parties fail to comply with this order, the Court shall dismiss this case without prejudice without any further warning.
3. The Clerk is **DIRECTED to DENY ALL PENDING MOTIONS AS MOOT**.

4. The Clerk shall **ADMINISTRATIVELY CLOSE** this case for statistical purposes only. This shall not affect the substantive rights of the parties.
