TO 9:00 P.M: GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 2:00 P.M. TO 9:00 P.M; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

SECTION 1. SECTION 2. That Mundaka, LLC dba Lucy's Retired Surfers Bar & Restaurant is hereby granted permission for the closure of James Street between Grinnell & Margaret Streets on the date and during the hours stated above.

SECTION 3. That Mundaka, LLC dba Lucy's Retired Surfers Bar & Restaurant is granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. That pursuant to Section 18-86 (b) of the Key West Code of Ordinances, Mundaka, LLC dba Lucy's Retired Surfers Bar & Restaurant is hereby granted permission allowing the

sale and consumption of alcoholic beverages within the enclosed area.
