A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE PURCHASE AND INSTALLATION OF FOUR SYNCROMATICS MOBILE DATA TERMINALS WITH ACCESSORIES, AS DESCRIBED IN THE ATTACHED PRICE QUOTE DATED FEBRUARY 13, 2018 FROM SYNCROMATICS CORPORATION, IN AN AMOUNT NOT TO EXCEED \$51,613.00 ON A SOLE SOURCE BASIS, AND IN THE BEST INTERESTS OF THE CITY, PURSUANT TO SECTION 2-797(1) AND 2-797(4)(b) OF THE CODE OF ORDINANCES; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE ANY NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 08-087, the City Commission awarded a bid for a Real Time Passenger Information system (RTPIS) to Syncromatics, Inc., and in Resolution No. 14-009 a second five-year agreement was approved on a sole-source basis; and

WHEREAS, the City has acquired four new transit buses, and the installation of Syncromatics systems on those vehicles is necessary to ensure that GPS and passenger information is available from all City buses through the same platform; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase and installation of four Syncromatics Mobile Data Terminals with accessories, as set forth in the attached price quote dated February 13, 2018 from Syncromatics is hereby approved in an amount not to exceed \$51,613.00, pursuant to Code of Ordinances Section 2-797(1), sole source procurement, and Section 2-797(4)(b), best interests of the City.

Section 2: This purchase will be funded through an FDOT 5339 Grant/FM441265-1/Contract GOL33 in the amount of \$51,613.00.

Section 3: That the City Manager or designee is authorized to execute any necessary documents on behalf of the City of Key West.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
