

An application was received requesting the removal of **(1) Podocarpus tree**. A site inspection was done on February 22, 2018 and documented the following:

Tree Species: Podocarpus (Podocarpus sp.)




















Diameter: 9.8"

Location: 50% (close to foundation of historic house, canopy against

structure)

Species: 50% (not on protected or not protected tree list)

Condition: 60% (fair)

Total Average Value = 53%

Value x Diameter = 5.1 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Podocarpus tree at 530 William Street to be replaced with 5.1 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.

Warranty Deed

This Warranty Deed made this 1st day of February, 2018 between Dimitri Kavoura, a single man whose post office address is P.O. Box 308, Key West, FL 33041, grantor, and J. Donald Peek, a married man whose post office address is 3103 Old River Road, Fortson, GA 31808, grantee:

(Whenever used herein the terms "grantor" and "grantee" include all the parties to this instrument and the heirs, legal representatives, and assigns of individuals, and the successors and assigns of corporations, trusts and trustees)

Witnesseth, that said grantor, for and in consideration of the sum of TEN AND NO/100 DOLLARS (\$10.00) and other good and valuable considerations to said grantor in hand paid by said grantee, the receipt whereof is hereby acknowledged, has granted, bargained, and sold to the said grantee, and grantee's heirs and assigns forever, the following described land, situate, lying and being in Monroe County, Florida to-wit:
