
An application was received requesting the removal of **(1) Mahogany tree**. A site inspection was done on March 16, 2018 and documented the following:

Tree Species: Mahogany (Swietenia mahagoni)

Diameter: 6"

Location: 60% (very close to property line) Species: 100% (on protected tree list)

Condition: 60% (fair-young tree with a growth lean toward the west)

Total Average Value = 73%

Value x Diameter = 4.3 replacement caliper inches

Note: Property owner is installing an off street parking spot in a new location and building a porch on the front of the structure.

Recommendation: Recommend approval of the removal of one (1) young Mahogany tree at 1108 Watson Street to be replaced with 4.3 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.

> Hope you are well. I am just writing to let you know we have finally been able to plant 9 pigeon plums which covers
the 24 caliper inches required. But we have really struggled to get any decent trees so it's been a long time in getting
them in!
>
> We have some palms to plant, but are not going to be able to do this within the 6 month period. We have really
struggled to get contractors over the past few months due to them working so hard elsewhere on hurricane effected
areas. And therefore we have had to leave alot of the landscaping work until we are back next October. We are leaving
in the middle of April as we have to go back to the UK.

> Is it possible we can delay planting the palms until next season? Also we have not actually taken a group of 3 palms
out yet, again due to lack of contractors, so most of the replacement palm requirement perhaps is not required yet?
>
> I would be grateful if you could contact me to discuss this, in the hope we can get an extention on the time needed to
replant the palms.
