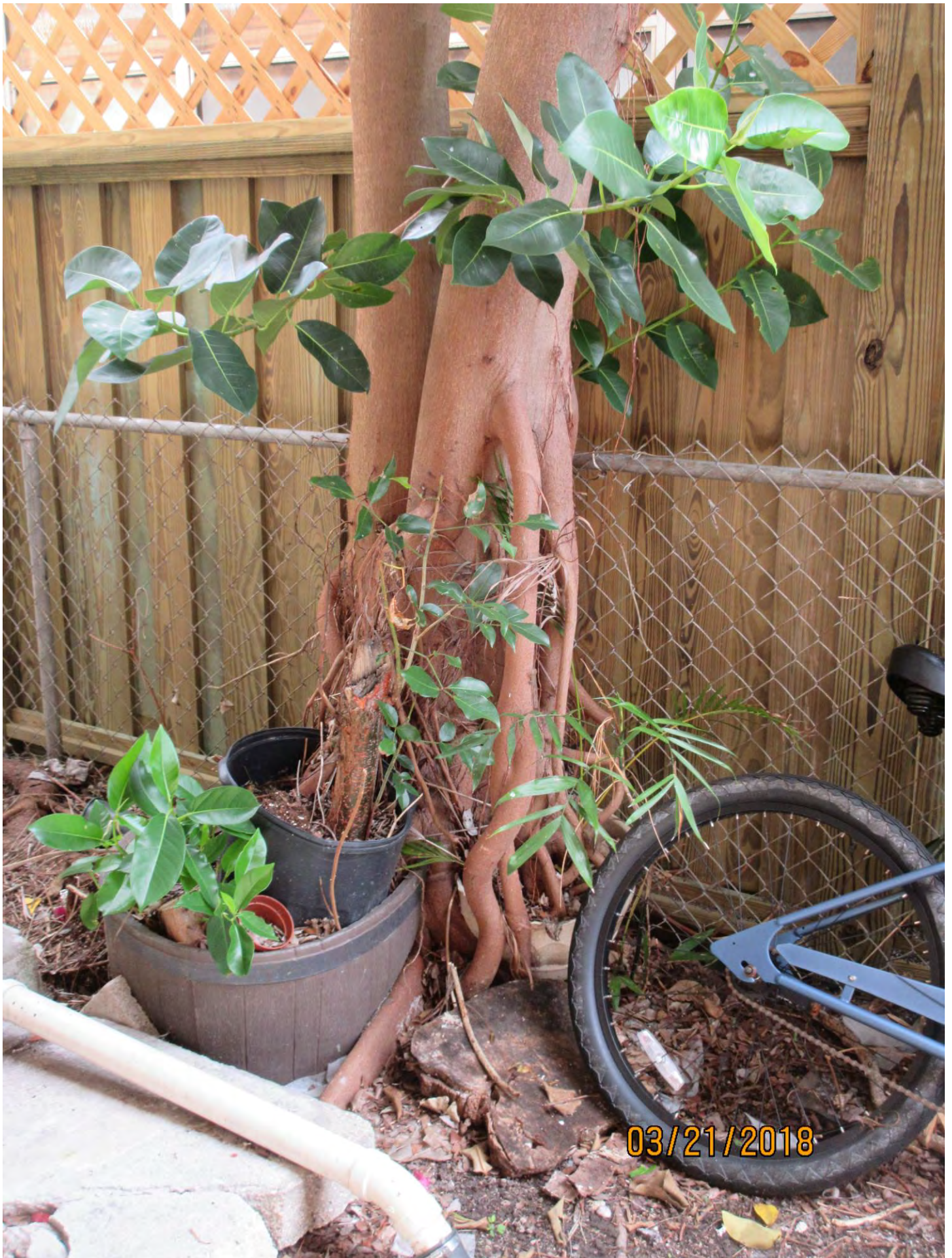

An application was received requesting the removal of **(1) Strangler Fig tree**. A site inspection was done on March 21, 2018 and documented the following:

Tree Species: Strangler Fig (*Ficus aurea*)

Diameter: 17.1"

Location: 40% (wrong tree/wrong place, too small of an area too close to fence and structures)

Species: 100% (on protected tree list)

Condition: 40% (poor structure, appears tree out grew its pot)

Total Average Value = 60%

**Value x Diameter = 10.6 replacement caliper inches**

**Recommendation: Recommend approval of the removal of one (1) Strangler Fig tree at 2523 Seidenberg Avenue to be replaced with 10.6 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.**

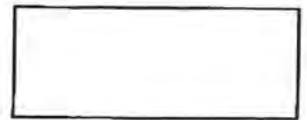
