#### Dear Dave:

Subsequent to your request we will prepare a revised sovereign submerged land lease survey in accord with the Florida Department of Environmental Protection (FDEP) Survey Requirements (SLER 0950) to support the City of Key West DEP Application No.: 0224891-003.

### Scope

The sovereign submerged land lease survey shall be prepared to include Items [a] through [s], where applicable.

We will not contact the Division of State Lands, Bureau of Survey and Mapping as suggested in the Survey Requirements Package, because we have submitted hundreds of submerged land lease surveys to the FDEP and are quite familiar with the process.

To satisfy some of the required items it will be necessary for us to mobilize a crew to obtain additional information:

- 1. Locate the concrete berthing pier directly west of the project.
- 2. Obtain water depths referenced to Mean Low Water from our westerly limits extending westerly to the navigation channel, being approximately 700 linear feet.
- 3. Recover boundary monumentation of the subject parcel, or identifiable corner of record to tie in the sovereign submerged land lease.

#### The office work will consist of:

- Researching and obtaining the sovereign submerged land leases of all adjacent upland land owners to determine the effect, if any of their respective submerged leases to this revised lease. Adjacent leases will be shown and, if conveyed by Trustees' Deed, the Deed Number will be included.
- 2. Revise the current submerged lease (Sovereignty Submerged Land Lease No. 440030665) to delineate the proposed seawall within the new "preempted area" and create a new legal description and sovereign submerged land lease survey.
- 3. Determine and delineate the riparian rights boundary lines extending into the Key West Harbor, from both sides of the upland property.
- 4. Calculate and dimension the distance from the concrete berthing pier and also the proposed sea wall to the projected riparian boundary lines.
- 5. Delineate the Mean High Water Line on the survey in accord with Chapter 177, Part II.

## Clarification

- Client shall arrange all access and permission with the Key West Aquarium to have our crew perform the bathymetric survey. Delays encountered due to access at no fault of Avirom & Associates may incur additional costs, which will be billed at our contracted hourly rates.
- The Mean High Water Line survey shall be in accord with Chapter 177, Part II Florida Statutes.
- This proposal is based on one mobilization by our crew to accomplish the project.

### Deliverable

We shall provide four (4) signed and sealed hard copies of the sovereign submerged land lease survey certified to "The Board of Trustees of the Internal Improvement Trust Fund of the State of Florida" and also to the "City of Key West", including an electronic PDF file.

## Time Frame

We can mobilize to the site within two (2) weeks after receipt of an executed contract and have the project completed within four (4) weeks after the fieldwork, which is anticipated to take three days.

## Fee:

The itemized fees to perform the above services are lump sum based on:

#### 1. Field Work

- a) Locate berthing pier and recover boundary monuments with mobilization (14 hours @ \$125.00 per hour) ...... \$ 1,750.00 lump sum
- b) Bathymetric survey from westerly boundary to channel of Key West Harbor
  ...... (Hydrographic Survey Crew with GPS sounder & boat) ... \$ 3,750.00 per day\*

### \* Minimum of one day required

TOTAL FIELD WORK..... \$ 5,500.00 lump sum

#### 2. Office Work

- a) Research adjacent sovereign submerged land lease, determine riparian line and write legal description (3 hours PLS @ \$100.00 per hour) .........\$ 300.00 lump sum
- b) Draft survey (12 hours CADD Drafting @ \$85.00 per hour) ........\$ 1,020.00 lump sum

#### General Conditions:

- 1. All invoices are due and payable in full upon receipt. Surveyor reserves the right to withhold certified prints and files to client or client's consultants until payment is made in full. If payment is not received within 45 days of the invoice date, Surveyor may terminate this agreement or suspend work under the agreement until payments have been made in full. The undersigned agrees to pay reasonable attorney fees up to 50% and all costs and expenses incurred by Avirom & Associates, Inc. in the collection of any past due obligation of the undersigned pursuant hereto.
