An application was received requesting the removal of **(1) Spanish Lime tree**. A site inspection was done on March 20, 2018 and documented the following:

Tree Species: Spanish Lime (*Melicoccus bijugatus*)

Diameter: 24.5"

Location: 70% (rear corner of property, large canopy tree close by)

Species: 100% (on protected tree list)

Condition: 50% (fair, hurricane damage to main branches, at least one branch tear close to main trunk)

Total Average Value = 73%

Value x Diameter = 17.8 replacement caliper inches

Need additional information from arborist who did the recent trimming of the tree to determine actual extent of damage and possible recovery of tree.

Karen, Here are some recent pictures of the Spanish Lime the owner would like to remove. The Tree is struggling and has some new insect activity in the upper crown which is causing cambium separation and deterioration. I am recommending removal and replacement for this situation. The option of a heavy Maintenance pruning to rebalance the canopy doesn't allow for lateral reduction and would only further damage the Tree.





Hi Karen,
Oh, I see where I didn't complete the application. I had already filled out the other permit for the extension and was thinking it could just be connected to that same owner name, etc. I will get this filled out and completed. Thanks.

As far as having an arborist heavily trim it, when I had the tree guys trim the debris and broken areas after the Irma storm, they commented that the tree will need to be removed at some point soon because of its condition. I would prefer to have it removed now, particularly because it is easy to get

equipment back there vs after we renovate it will be very difficult to get heavy equipment necessary to do anything to it. Starting with a fresh tree that gets tended to properly makes much more sense and makes sense for safety reasons.

When is the next Tree Commission beyond April 9th? I may have a conflict with that date and was going to email you today inquiring about this. I plan to represent myself since I have not hired anyone recently to deal with this tree.

Thank you. I hope you are doing OK since Irma.
