**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING QUEPASA KW, INC. TO CONDUCT THE PET MASQUERADE AT THE TRUMAN WATERFRONT AMPHITHEATRE ON WEDNESDAY, OCTOBER 24, 2018, FROM 4:00 P.M. TO 9:00 P.M; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Quepasa KW, Inc. wishes to conduct the Pet Masquerade at the Truman Waterfront Amphitheatre between the hours of 4:00 p.m. to 9:00 p.m. on Wednesday, October 24, 2018.

**NOW THEREFORE, BE IT RESOLVED**, by the City Commission of the City of Key West, Florida;

**SECTION 1.** Quepasa KW, Inc. is hereby granted permission to conduct the Pet Masquerade on the date and during the hours stated above; **PROVIDED** all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

**SECTION 2.** That pursuant to Section 18-86 of the Key West Code of Ordinances, Quepasa KW, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

**SECTION 3.** Quepasa KW, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash container will be used and that they will be placed side by side.

**SECTION 4.** Quepasa KW, Inc. will be responsible for the rental fee of five hundred (\$500.00) dollars. In addition, Quepasa KW, Inc. will be required to pay the Police, Fire and Community Services before the event.

**SECTION 5.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
