A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PROCUREMENT PURSUANT TO SECTION 2-797(2) AND SECTION 2-797(4)(b) OF THE CITY'S CODE OF ORDINANCES, FOR THE PURCHASE OF A 10-STALL SHOWER TRAILER (\$43,900) AND A 4-STALL RESTROOM TRAILER (\$17,999)FROM NATIONAL RESTROOM TRAILERS, LLC. FOR USE AT THE KEYS OVERNIGHT TEMPORARY SHELTERS (KOTS), AMOUNT NOT TO EXCEED \$61,899.00; AUTHORIZING NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the restroom and shower facilities at KOTS present a life safety hazard and require immediate replacement;

WHEREAS, the City Manager acted without delay, using powers authorized under Section 2-797(2) of the City's Code of Ordinances, to authorize an emergency procurement in the amount of \$61,899.00 to ensure that safe sanitary facilities are promptly provided at the shelter site; and

WHEREAS, pursuant to City Code Section 2-797(4)(b), the City Manager finds that exceptional circumstances exist to exempt a purchase from the competitive bid requirements in the best interests of the City; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the City Commission, in accordance with Section 2-797(2) and 2-797(4)(b) of the Code of Ordinances, hereby ratifies the emergency procurement of a ten-stall shower trailer and a 4-stall restroom trailer for use at KOTS in an amount not to exceed \$61,900.00 from National Restroom Trailers, LLC.

Section 2; This procurement was funded from account 001-6901-569-64, and the City Commission hereby ratifies the following fund transfers to account 001-6901-569-64 for this procurement: a transfer of \$20,000 from account 001-1909-519-34, a transfer of \$25,000 from account 001-1909-519-46 a transfer of \$10,000 from account 001-1909-519-52 and a transfer of \$15,000 from account 001-1909-519-64.

Section 3: That the City Manager is authorized to execute any necessary documents upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
