A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF 100 AXON BODY II BODY WORN CAMERAS, DOCKS AND RELATED EQUIPMENT, PURSUANT TO CITY ORDINANCES 2-797(3) FROM AXON INTERNATIONAL INC. IN AN INITIAL AMOUNT NOT TO EXCEED \$54,408.80; AUTHORIZING A FIVE-YEAR EXTENDED SUPPORT PLAN IN THE AMOUNT OF \$27,840.00 ANNUALLY FOR YEARS TWO THROUGH FIVE OF THE PLAN; AUTHORIZING BUDGET TRANSFERS AND APPROVING THE USE OF LAW ENFORCEMENT TRUST FUNDS FEDERAL FORFEITURE ACCOUNT FUNDS FOR A PORTION OF PURCHASE: AUTHORIZING THE MANAGER OR DESIGNEE TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, section 2-797(3) of the Code of Ordinances authorizes purchases pursuant to government contracts; and

WHEREAS, Florida Statutes section 932.7055 provides authority for the expenditure of state police forfeiture funds; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of 100 Axon Body II body worn cameras, with docks and related equipment pursuant to Key West Code of Ordinances sections 2-797(3), in an initial amount not to exceed \$54,408.80, in accordance with the April 27, 2018 quotation from AXON Enterprise, Inc. is hereby approved.

Section 2: That payment in the amount of \$27,840.00 annually for the extended assurance plan in years two through five is hereby authorized.

Section 3: That \$27,204.40 of the cost for the first year of this procurement will be allocated in FY 17/18 from account 101-2101-521-6400, and \$27,204.40 will be allocated from the Law Enforcement Trust Fund, Federal forfeiture funds account #172-2113-521-6400. (A total contract amount of \$165,768.80 over five budget years, inclusive of initial purchase and extended service plan is authorized.)

Section 4: That the City Manager or designee is authorized to execute any necessary documents, upon consent of the City Attorney.
