A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING OHWOOK PRODUCTIONS, INC. TO CONDUCT AN THE 2ND ANNUAL AMERICANA FOLK COUNTRY MUSIC FESTIVAL AT THE TRUMAN WATERFRONT AMPHITHEATRE ON JANUARY 30, 2019 TO FEBRUARY 2, 2019 FROM 3:00 P.M. TO 12:00 A.M AND A STREET CLOSURE ON THE 200 BLOCK OF DUVAL STREET FOR A KICKOFF PARTY ON TUESDAY, JANUARY 29, 2019 FROM 6:00 P.M. TO 10:00 P.M; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCE PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCE FROM 6:00 P.M. TO 10:00 P.M ON TUESDAY, JANUARY 29, 2019; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Ohwook Productions, Inc. wishes to conduct a Country Music & Americana/Folk Music Festival at the Truman Waterfront Amphitheatre on January 30-February 2, 2019 and a Kickoff party on the 200 block of Duval Street on Tuesday, January 29, 2019 from 6:00 p.m. to 10:00 p.m.; and

WHEREAS, this event shall take place on the grounds of the Truman Waterfront Amphitheatre on January 30, 2019-February 2, 2019 from 6:00 p.m. to 10:00 p.m. and

WHEREAS, the sponsors anticipate that amplified music will be played during the event;

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida;

SECTION 1. That Ohwook Productions, Inc. is hereby granted permission to conduct a "Country Music Concert" on the date and during the hours stated above;

PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and the organizations meet the terms and conditions set forth by the City Manager.

SECTION 2. That pursuant to Section 18-86 of the Key West Code of Ordinances, Ohwook Productions, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

SECTION 3. That Ohwook Productions, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time herein described.

SECTION 4. that Ohwook Productions, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used that that they will be placed side by side.

SECTION 5. that Ohwook Productions, Inc. will be responsible for the user fee of 8,000.00 for the first (1) day, 6,000.00 for the second (2) day, four thousand (4) for the following two (2) days and \$1.00 per ticket to the city, as well as any other cost associated with the event including Fire, Police and Community Services.

SECTION 6. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and
