A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING WORK ORDER #21 AND WORK ORDER #22 UNDER THE CITY'S RIGHT-OF-WAY IMPROVEMENT CONTRACT WITH CHARLEY TOPPINO & SONS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$201,570.97 FOR RESURFACING PORTIONS OF 8th STREET AND 11th STREET; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 17-106, the City Commission approved a three-year Right-of-Way Improvements contract with Charley Toppino & Sons, Inc.; and

WHEREAS, to improve roadway surface conditions, City staff recommends approval of Work Order #21 to mill and pave 11th Street between Flagler and Staples Avenue, and Work Order #22 to mill and pave 8th Street between Flagler and Patterson Avenue, including trench restoration as needed;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached Work Orders #21 and #22 under the City's Right-of-Way Improvement Contract with Charley Toppino & Sons, Inc., for resurfacing portions of 8th Street and 11th Street, and related work as necessary, is hereby approved in a total amount not to exceed \$201,570.97.

Section 2: That project funding is budgeted for right of way improvements in account 102-4102-541-6300, and budget transfers are authorized as necessary for Work Order #21 in the amount of \$24,706.08 (Project Number II41021802) and for Work Order #22 in the amount of \$176,864.89 (Project #II41021802) is hereby approved.

Section 3: That the City Manager is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
