A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER FROM PEREZ ENGINEERING AND DEVELOPMENT, INC. IN THE AMOUNT OF \$88,340.00 FOR BID PHASE, PERMIT RENEWAL SERVICES AND FIELD TEST PHASE SERVICES FOR THE MECHANICAL INTEGRITY TESTING OF DEEP INJECTION WELL IW-1 AND IW-2; AUTHORIZING NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 17-207, the City Commission approved a contract with Perez Engineering and Development, Inc. for General Engineering Services; and

WHEREAS, the City's two deep injection wells are permitted by Florida Dept. of Environmental Protections permit numbers 327710-001-UO/5W and 327710-00-UO/5W, and are required to be tested for mechanical integrity every five years; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That a Task Order for bid phase, permit renewal services and field test phase services for the mechanical integrity testing of Deep Injection Well IW-1 and IW-2, is approved in an amount not to exceed \$88,340.00.

Section 2: That a budget transfer in the amount of \$88,340.00 will be transferred from reserves to account 401-3504-535-3100 for this work order. The expense has been accounted for in the sewer rate model for FY19.

Section 3: That the City Manager is authorized to execute any necessary documents, upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
