A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING WORK ORDER #18 and WORK ORDER #19 UNDER THE CITY'S RIGHT-OF-WAY IMPROVEMENT CONTRACT WITH CHARLEY TOPPINO & SONS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$874,543.49 FOR RESURFACING AND AMERICANS WITH DISABILITIES ACT (ADA) SIDEWALK IMPROVEMENTS ON FLEMING STREET BETWEEN WHITEHEAD STREET AND WHITE STREET; AUTHORIZING NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 17-106, the City Commission approved a three-year Right-of-Way Improvements contract with Charley Toppino & Sons, Inc.; and

WHEREAS, City staff recommends approval of Work Order #18 to construct ADA compliant sidewalks as necessary along Fleming Street, and Work Order #19 to Mill and pave Fleming Street between White and Whitehead Streets; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached Work Orders #18 and #19 under the City's Right-of-Way Improvement Contract with Charley Toppino & Sons, Inc. in a total amount not to exceed \$874,543.49, for mill and pave, ADA sidewalk construction and related work as necessary, is hereby approved.

Section 2: That funding is budgeted for right of way improvements in account 102-4102-541-6300, and necessary budget transfers are authorized as necessary for Work Order #18 in the amount of \$390,696.19 (Project Number II41021801) and \$483,847.30 for Work Order #19 (Project #II41021802) is hereby approved.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
