A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, ACCEPTING THE RECOMMENDATION OF THE ART IN PUBLIC PLACES BOARD (AIPP) TO AWARD THE PROPOSAL OF CIVICMOXIE IN RESPONSE TO RFP 009-18 FOR AN ARTS AND CULTURE MASTER PLAN CONSULTANT IN SUPPORT OF KEY WEST'S NATIONAL ENDOWMENT OF THE ARTS OUR TOWN GRANT; AUTHORIZING THE CITY MANAGER TO EXECUTE THE ATTACHED CONTRACT IN CONFORMANCE WITH THE TERMS AND CONDITIONS CONTAINED IN RFP 009-18, UPON THE ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 17-084, the City Commission accepted NEA Our Town Grant Award #15-4292-7098, in support of arts master plan and public art installations at the Truman Waterfront Park; and

WHEREAS, the City issued Request for Proposals No. 009-18 for an Arts and Culture Master Plan Consultant in support of the City's NEA Our Town Grant, and five proposals were opened on June 20, 2018; and

WHEREAS, an evaluation panel convened at a properly noticed meeting conducted consistent with the "Sunshine Law," on July 3, 2018, and ranked all proposals upon specific criteria, with Civic Moxie as the top-ranked firm; and

WHEREAS, on July 10, 2018, the Art In Public Places Board considered the ranking committee's recommendation, and unanimously recommended that the City Commission award the RFP to CivicMoxie as the highest-ranked firm.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission accepts and approves the recommendation of the AIPP, and hereby awards the highest-ranked proposal by CivicMoxie, in response to RFP No. 009-18, for an Arts and Culture Master Plan Consultant in support of Key West's National Endowment of the Arts "Our Town" Grant.

Section 2: That the City Manager or his designee is hereby authorized to execute the attached contract with the highest-ranked firm, CivicMoxie, in conformance with terms and conditions contained in the proposal package, upon the advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
