A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, REJECTING ALL PROPOSALS RECEIVED FOR KEY WEST AMPHITHEATER VENUE MANAGEMENT SERVICES IN RESPONSE TO RFP NO. 006-18 PURSUANT TO SECTION 2-834(4) OF THE CODE ORDINANCES; CANCELLING RFP 006-18; DIRECTING STAFF TO PREPARE AND ISSUE A REQUEST FOR QUALIFICATIONS (RFQ); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City issued Request for Proposals No. 006-18 on for Key West Amphitheater Venue Management Services, and three proposals were received on May 2, 2018; and

WHEREAS, an evaluation panel, comprised of City staff and a member of the Truman Waterfront Advisory Board, convened at a properly noticed meeting conducted consistent with the "Sunshine Law," on May 18, 2018, and ranked all proposals upon specific criteria; and

WHEREAS, the City's intention was to solicit proposals from proposers that would not require capital outlay by the City, unfortunately all proposals required City outlay of funds, and the proposals failed to provide detailed financial management plans for the facility; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That all proposals received in response to RFP 006-18 for Key West Amphitheater Management are hereby rejected pursuant to section 2-834(4) of the Code of Ordinances.

Section 2: That RFP No. 006-18 is hereby cancelled.

Section 3: That City staff is directed to prepare and issue a Request for Qualifications for Key West Amphitheater Venue Management.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
