**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING FREDERICK DOUGLASS SCHOOL BLACK EDUCATORS PROJECT, INC TO CONDUCT A TRILOGY MUSIC FEST AT THE TRUMAN WATERFRONT AMPHITHEATRE ON SATURDAY, MARCH 9, 2019, FROM 5:00 P.M. TO 10:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Frederick Douglass School Black Educators Project, Inc. wishes to conduct a Trilogy Music Fest at the Truman Waterfront Amphitheatre between the hours of 5:00 p.m. to 10:00 p.m. on Saturday, March 9, 2019.

**NOW THEREFORE, BE IT RESOLVED**, by the City Commission of the City of Key West, Florida;

**SECTION 1.** Frederick Douglass School Black Educators Project, Inc. is hereby granted permission to conduct the Trilogy Music Fest on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

**SECTION 2.** That pursuant to Section 18-86 of the Key West Code of Ordinances, Frederick Douglass School Black Educators, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

**SECTION 3.** That Frederick Douglass School Black Educators Project, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash container will be used and that they will be placed side by side.

**SECTION 4.** That Frederick Douglass School Black Educators Project, Inc. will be responsible for the rental fee of five hundred (\$500.00) dollars. In addition, Frederick Douglass School Black Educators Project, Inc. will be required to pay the Police, Fire and Community Services before the event.

**SECTION 5.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
