




An application was received requesting the removal of **(1) Sapodilla tree**. A site inspection was done and documented the following:






















Diameter: 24.5"

Location: 60% (tight area, not a lot of room for future growth, backyard

tree)

Species: 100% (on protected tree list)

Condition: 40% (poor, some decay, old cuts, tree once had two trunks with

one having been removed now a lot of regrowth, poor structure)

Total Average Value = 66%

Value x Diameter = 16.1 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Sapodilla tree at 1221 Margaret Street to be replaced with 16.1 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.
