A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A PURCHASING EXCEPTION PURSUANT TO SECTION 2-797 OF THE CODE OF ORDINANCES, TO ALLOW AN INCREASE NOT TO EXCEED \$5,000.00 IN CUMULATIVE EXPENDITURES DURING FY 17-18 TO STRUNK ACE HARDWARE (FROM \$105,000 TO \$110,000); AUTHORIZING PURCHASING EXCEPTIONS PURSUANT TO SECTION 2-797 FOR PAT'S PUMP & BLOWER IN AN AMOUNT NOT TO EXCEED \$30,000.00, AND KEYS MOTORS, LLC IN AN AMOUNT NOT TO EXCEED \$26,000.00; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$20,000.00; and

WHEREAS, in Resolution 17-269, the City Commission approved purchasing exceptions for several sole source, government contract and/or blanket purchase orders in excess of \$20,000.00, including Strunk Ace Hardware; and

WHEREAS, Strunk Ace supplies tools and parts for maintenance, improvements and repairs which are essential to the health and welfare of the citizens of the City of Key West; and

WHEREAS, repair, maintenance and improvement of City facilities and vehicles have also necessitated the purchase of parts and supplies in excess of \$20,000.00 from Pat's Pump and Blower and Keys Motors, LLC in FY 18; and

WHEREAS, the City Manager finds that pursuant to section 2-797 of the Code of Ordinances, it is in the best interests of the City to adjust the amount of authorized expenditures previously approved in Resolution 17-269 for Strunk Ace Hardware, and to grant purchasing exceptions for Pat's Pump & Blower and Keys Motors, LLC.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That an increase of \$5,000.00 to funds previously authorized in Resolution No. 17-269, is hereby approved for Strunk Ace Hardware in accordance with Key West City Code of Ordinances section 2-797(4)(b) (to a total of \$110,000.00).

Section 2: That expenditures in an amount not to exceed \$30,000.00 are hereby authorized for Pat's Pump and Blower, and expenditures in an amount not to exceed \$26,900.00 are hereby authorized for Keys Motors, LLC, in accordance with Key West City Code of Ordinances section 2-797.

Section 3: That necessary budget transfers within the applicable cost center(s) are hereby authorized.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
