A RESOLUTION OF THE NAVAL PROPERTIES LOCAL REDEVELOPMENT AUTHORITY OF THE CITY OF KEY WEST (LRA) APPROVING A TASK ORDER FOR K2M DESIGN FOR PROFESSIONAL SUPPORT SERVICES DURING BIDDING AND CONSTRUCTION OF TRUMAN WATERFRONT PARK PHASE 1B, IN AN AMOUNT NOT-TO-EXCEED \$125,345.00; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 17-190, the City approved a Contract for General Architectural Services with K2M Design; and

WHEREAS, in Resolution 18-080, the LRA directed K2M Design to design Phase 1B of the Truman Waterfront Park and prepare drawings and specifications for construction. Phase 1B includes a multi-purpose field, renovation/addition to Building 1287, fruit tree grove, and landscape/hardscape improvements; and

WHEREAS, City staff requested a Task Order proposal from K2M Design for professional support services during bidding and construction of Truman Waterfront Phase 1B, and recommends approval of the Task Order by the LRA.

NOW, THEREFORE, BE IT RESOLVED BY THE NAVAL PROPERTIES LOCAL REDEVELOPMENT AUTHORITY, AS FOLLOWS:

Section 1: That the attached Task Order for K2M Design, under the City's General Architectural Services Agreement, for Truman Waterfront Park Phase 1B professional support services during bidding and construction, in an amount not-to-exceed \$125,345.00, is hereby approved.

Section 2: That this task order is funded in account 101-4303-543-6300 (Project Number IS43031801-Truman Waterfront Park Phase 1B).

Section 3: That the City Manager is hereby authorized to execute documents on behalf of the LRA, upon advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Authority.
