A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED ART IN PUBLIC PLACES BOARD SELECTIONS OF CITY HALL PUBLIC ART FOR THE JOSEPHINE PARKER CITY HALL AT HISTORIC GLYNN R. ARCHER SCHOOL IN RESPONSE TO RFP #003-19; AUTHORIZING THE CITY MANAGER TO NEGOTIATE IF NECESSARY, AND EXECUTE AGREEMENTS UPON CONSENT OF THE CITY ATTORNEY BETWEEN THE CITY OF KEY WEST AND FOLLOWING FOUR ARTISTS: J.H. (TARGETED SPACE #1 WALL ABOVE CHAIRS IN FRONT LOBBY -- \$28,000.00), JIM SALEM (WALL ABOVE CHAIRS ACROSS FROM THE CITY CLERK'S OFFICE \$10,000.00), RALPH GILBERT (TARGETED SPACE #3, WALLS ABOVE **RAILINGS** IN HALLWAY/WALKWAY TO BREEZEWAY TO REAR BUILDING - \$60,000.00), AND CRAIG BERUBE GRAY (TARGETED SPACE #4 - EXTERIOR BUTTERFLY GARDEN CORNER OF UNITED AND GRINNELL STREETS - \$28,000.00); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, RFP #003-19, was advertised on October 12, 2018, and 44 proposals were received in response to the RFP and addendums on November 28, 2018. Of the 44 proposals, 41 were determined to be responsive and responsible; and

WHEREAS, the Art in Public Places (AIPP) Board, along with two non-voting members appointed by the City Manager, acted as the Selection Ranking Committee and considered at public meetings the 41 responsive proposals on December 10th and December 13th, 2018, ranking the projects pursuant to a process set forth in the RFP package; and

WHEREAS, the AIPP Board recommends City Commission approval of the four highest ranked projects for specific sites, as set forth in this Resolution; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Selection 1: That the four Art in Public Places Board Selection Committee's recommended selections for site-specific, commissioned, original and permanent public art for the Josephine Parker City Hall at Historic Glynn R. Archer School are hereby approved in Response to RFP #003-19.

- Section 2: That the City Manager is authorized to negotiate (as necessary) and execute contracts in substantial conformance with the RFP and recommendations of the AIPP Selection Committee, upon consent of the City Attorney, for the four artists/proposals as follows:
- 1. J.H. ALLEN (Targeted Space #1 Wall above chairs in Front Lobby -- \$28,000.00)
- 2. JIM SALEM (Targeted Space #2 Wall above chairs across from the City Clerk's Office -- \$10,000.00)
- 3. RALPH GILBERT (Targeted Space #3, Two walls above railings in the hallway/walkway to breezeway to rear building --\$60,000.00)
- 4. CRAIG BERUBE GRAY (Targeted Space #4 Exterior Butterfly Garden Corner of United and Grinnell Street \$28,000.00)
- Section 3: That funds for these art projects are budgeted as a component of the construction of City Hall. Funds remaining in the City Hall art budget shall be used for future projects.

Section 4: That this Resolution shall go into effect

signature of the Presiding Officer and the Clerk of the Commission.
